Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Scope and Content

The materials in FOIA 2023-0173-F are a selective, not necessarily all-encompassing, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2023-0173-F requested materials from Tucker Eskew's files related to the creation, maintenance, planning, usage, design, and updating of the Bush White House Website as well as the creation of a social media presence in 2001.

This FOIA primarily contains printouts, memorandums, and printed email correspondence. The printouts feature pages of the White House Website, utilized for drafts of changes to the website. Specifically, these changes focused on the Office of Global Communication's portion, the Global Listening Event and the associated countries. The proposed modifications convey and display necessary materials that align with President Bush's objectives for the Office of Global

Communication. The memorandums offered dialog and documentation concerning White House Website management, updates, and the inclusion of President Bush's "Non Negotiable Demands of Human Dignity." The printed email correspondence features White House personnel discussing the formation and updates to the Office of Global Communication Website.

System of Arrangement

The materials in FOIA 2023-0173-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
