### Daniel Bartlett's Records on the Bush White House Website and Social Media Presence Between 2001 - 2007

#### Extent

7 folders, approximately 460 pages

#### Access

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### Scope and Content

The materials in FOIA 2023-0174-F are a selective, not necessarily all-encompassing, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2023-0174-F requested materials from Daniel Bartlett's files related to the creation, maintenance, planning, usage, design, and updating of the Bush White House Website as well as the creation of a social media presence between 2001 – 2007.

This FOIA primarily contains printouts, memorandums, and printed email correspondence. The printouts feature pages of the White House Website, utilized as samples to produce several updates. These updates concerned the White House's approach to forums through the White House Website, particularly, the promotion of the "Ask the White House" initiative. This endeavor allowed the public to ask questions to the administration, online. Additionally, the

printed email correspondence covered the forum as well as preparations for a virtual tour of the Oval Office. The memorandums encompass proposed schedules for the virtual tour of the Oval Office, and initiatives from the First Lady.

### **System of Arrangement**

The materials in FOIA 2023-0174-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
