## **Scope and Content**

The materials in FOIA 2023-0178-F are a selective, not necessarily all-encompassing, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2023-0178-F requested materials from Karl Rove's files related to the creation, maintenance, planning, usage, design, and updating of the Bush White House website as well as the creation of a social media presence between 2001 and 2007.

This FOIA primarily contains printed webpages, site maps, and annotations and corrections to be made to the website.

# **System of Arrangement**

The materials in FOIA 2023-0178-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in this collection area – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
