Scope and Content

The materials in FOIA 2024-0020-F are a selective, not necessarily all-encompassing, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2024-0020-F requested materials related to White House Staff Member Office Files for Nick Calio pertaining to tax or taxes.

This FOIA primarily contains handwritten notes, personalized place cards, seating charts, correspondence and printed emails. Most records pertain to planning the Tax Bill Signing Ceremony held on June 7, 2001. Also present are schedules and a list of invitees.

System of Arrangement

The materials in FOIA 2024-0020-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
