Scope and Content

The materials in FOIA 2017-0198-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2017-0198-F requested materials from the White House Office of Records Management that contain any reference to Steve Jobs.

This FOIA primarily contains briefing materials, schedules, memorandums, printed magazine articles, speech and letter drafts. The briefing materials are notifications for President George W. Bush and White House staff members, prior to events, particularly those with scheduled remarks. The schedules include itineraries and drafts, for respective occasions. These occasions include the Strategic Economic Dialogue with China, STS-118 Endeavour Tour, the 125th Thomas Edison Anniversary Gala, the National Park Foundation Leadership Summit, and the 2001

National Design Awards. The memorandums contain dialogue between White House personnel analyzing press coverage, voting patterns, and event preparation. The printed magazine articles are features from TIME Magazine and The Washington Post. The drafts of speeches and letters from President George W. Bush entail multiple copies with staff edits.

System of Arrangement

The materials in FOIA 2017-0198-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.
