### Records on White House Correspondence Dealing with Curt Weldon and Russia

#### Extent

24 folders, approximately 880 pages / 85 assets

#### Access

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### Scope and Content

The materials in FOIA 2018-0206-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0206-F requested materials related to White House correspondence about or dealing with former congressman Curt Weldon and his concerns about Russia.

This FOIA primarily contains written correspondence, printed webpages, staff comments on news articles, copies of a transcript from a hearing of the House Armed Services Committee, copies of a night note, and email correspondence, all referring to various political issues or events that include Curt Weldon and Russia.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

### **System of Arrangement**

The materials in FOIA 2018-0206-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files, Staff Member Office Files, and George W. Bush Presidential Electronic Records.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) and folders processed in response to FOIA 2018-0206-F:

#### ***George W. Bush Electronic Records***

ARMS contains 17 assets, of which 14 are released in full and 3 are withheld in part.  
Exchange contains 65 assets, of which 55 are released in full and 10 are withheld in full.  
Exchange - 40 Days contains 1 asset, which is released in full.  
OA contains 2 assets, all of which are withheld in part.
