Dear Mr. President:

On April 19, 2005 the people of Illinois will formally dedicate the new Abraham Lincoln Presidential Museum (the companion library having already been opened this fall). The new facility is a presidential museum unlike any other. Combining scholarship and showmanship, its nearly 50,000 square feet of exhibits employ the latest technology to immerse visitors in Lincoln's life and times. As a bold alternative to the historical illiteracy that sometimes threatens to engulf our culture, the Abraham Lincoln Presidential Library and Museum embodies your own efforts in the post -9/11 climate to foster greater awareness of America's defining ideas and institutions.

I should also note that the ALPLM is very much a product of bipartisanship, both here in Springfield and in the nation's capitol. It has enjoyed the support of three Governors, not to mention the strong backing of Senator Durbin, Speaker Hastert, the entire Illinois Congressional delegation and state legislators of both parties. While roughly two-thirds of the project's funding has come from the state of Illinois, much of the rest has been provided by the federal government and the city of Springfield, augmented more recently by a robust private sector fundraising effort.

Both a national treasure and a world class institution, we believe the ALPLM will be an international place of pilgrimage. Nearly a century and a half after Lincoln pledged himself and his countrymen to "a new birth of freedom" on the battlefield at Gettysburg, his words have never seemed so contemporary. Under your leadership, Mr. President, thousands of young Americans are putting their lives on the line to extend the blessings of freedom to nations only recently enslaved.

With this in mind, I would like to formally invite you to participate in the April 19th ceremonies dedicating the new museum. I can assure you of a very warm welcome. I think you might also find the ALPLM to be a source of inspiration as you begin to think about your own presidential library and museum. Finally, you should know that we are simultaneously approaching Prime Minister Tony Blair in hopes he might agree to be the first recipient of an international Lincoln Leadership Prize to be presented at a dinner on the evening of April 18th.

Thanks in advance for your consideration. Patti joins me in wishing you and Mrs. Bush a new year filled with blessings.

Dear Karl:

Congratulations on your appointment to Deputy Chief of Staff. The needs of the country will be well served by your willingness to take on these added responsibilities.

Quite understandably, I expect that the appointments by the President to the Board of the Presidio Trust may not warrant a high priority. As you know, I continue to be very concerned about the qualifications of the new Board members, since they will have significant long term impact on the work we started and moved forward successfully over the last eight years. It occurs to me that you might want to move this issue on to others in the White House and I would be glad to pursue it with them, however you direct. If so, I would hope that you would recommend that the three individuals we have suggested would be the designated candidates for appointment.

These three are T. Robert (Bob) Burke, Nancy R. Conner and Curtis F. Feeny. Earlier this week I sent their resumes to Susan Ralston in your office and they have also been delivered to and discussed with Ms. Casey Jones in the Office of Personnel.

Bob Burke is a different person than the individual you described to me the other day. Bob is a Democrat, but is not politically active and has made an \$8,000 contribution to a Republican candidate (Ameri) for the House in Oregon and several years ago a contribution to Senator Feinstein. He has no other gifts to Federal campaigns or any significant gifts or activities with any state of local campaigns. Nancy is a Republican and has made no political contributions in many years. Curtis is an Independent and has no political contributions.

Bob and Curtis bring strong experience in the field of real estate development and business, including their tenure on Boards at Stanford where they worked with Condoleezza Rice, who knows them well. Nancy is broadly respected here for her knowledge of landscaping, parks and open space and her work with community boards and organizations. All three also have extensive personal experience with private philanthropy, which will be needed in the Presidio's future. The three would make an excellent group of diverse talents much needed for the next phase of the work at the Presidio and its development as an outstanding public asset.

I look forward to hearing how you would like to proceed with the appointments and will appreciate your assistance in moving them along.



Senator John McCain Munich Security Conference 2005 "Security in the Middle East: New Challenges for NATO and the EU"

Since we met last year, the people of Afghanistan, the Palestinian Authority and Iraq have chosen new leaders in democratic elections, an "Orange Revolution" has brought a new dawn of freedom in Ukraine, and Israeli and Palestinian leaders have declared an end to four years of conflict. As we, the Atlantic community, sketch out our vision for the future, we should reflect on these events and consider how much more we can do – together – to build a freer and more secure world.

The Iraq question continues to darken relations among transatlantic friends, but the shadow lightens with each passing month. Many challenges remain, and the road ahead is arduous. But we are beginning to put the past divisiveness behind us, and starting again to identify shared challenges as collaborative opportunities.

These new events unfold as our fundamental understanding of international security evolves. For many years we believed that bonds of friendship among governments led to peace, irrespective of their domestic nature, and that a despotic ally was preferable to an unfriendly democracy. The events of September 11 showed most painfully that this form of statecraft can be a recipe for complacency and danger.

We have learned that, where repression rules, the lack of political participation and economic opportunity engenders despair and even extremism. Nowhere is this problem more acute today than in the broader Middle East, and the stagnating status quo there demands attention. The promotion of democracy and freedom are simply inseparable from long-term security in this region, and security in the broader Middle East is fundamentally linked to security elsewhere – including in Europe and North America. When the security of New York or Madrid or Munich depends in part on the degree of freedom in Riyadh or Baghdad or Cairo, then we must promote democracy, the rule of law, and social modernization just as we promote the sophistication of our weapons and the modernization of our militaries.

This is not merely an American view or a temporary whim. Last year before this conference, the German Foreign Minister said that "Following 11 September 2001, neither the U.S. nor Europe and the Middle East itself can tolerate the status quo in the Middle East any longer." Mr. Fischer was absolutely right, as was his observation that we must respond to jihadist terrorism with all of the instruments available – military, when absolutely necessary, but not military alone. The power of attraction can be as powerful as the ability to destroy evil. In recognition of this new reality, the G-8 launched the Broader Middle East/North Africa initiative at Sea Island, and NATO launched its Istanbul Cooperation Initiative – both of which are building blocks on which we can do more – much more – to engage the broader Middle East. Working in partnership with willing reformers, the U.S. and Europe must deepen their long-term commitment to use economic, political, and diplomatic resources to promote positive change in the region.

Nowhere is this more critical today than in Iraq. The outcome there will affect Europe as much as, if not more than, the United States. None of us can afford failure, with all of the implications that a failed state - in the heart of the Middle East - would have for our homelands. The recent elections may be a turning point, but we still face a long, difficult, and expensive road ahead. The battle, once between insurgents and the coalition, is now waged between the insurgents and the Iraqi people. Today they need our help, and we must not remain unmoved. I fully understand that there exists in some European countries lingering, and significant, domestic opposition to the coalition military operation in Iraq. But I cannot believe most of those who opposed the war also oppose providing any assistance to the Iraqi people today. Even if that were opposed, as political leaders, faced with a serious issue whose outcome affects us all, we must make decisions based on what is right, not merely what is popular. The leaders of the world's great powers cannot stand idle during the most significant political transformation of our time. Given the catastrophic implications of failure in Iraq, we should all look at the situation there as an emergency that requires immediate attention.

Security is the preeminent requirement. Iraqis can sort out their own politics, but they cannot do it in the absence of order. Our alliance should be doing much more to help provide it. Last year there was much talk about a NATO brigade that would train Iraqi troops, but today there are fewer than 500 NATO representatives in Iraq. Without well-trained, well-equipped Iraqi forces that can provide real security throughout the country, it will be very difficult to make progress on the economic and political fronts. So I urge every member of NATO to be as generous as possible when examining their potential security contributions. At the same time, hundreds of thousands of Iraqi troops, however skillful, will be of little use unless the people of Iraq believe that the new government truly represents their interests. The parliament, free and fairly elected, is now the source of Iraq's democratic legitimacy. As it begins its work, its list of requirements will be long – from computers to staff, from technical assistance to security – and significant resources will be required to properly represent the people. In the ministries too, the Iraqis need help to build institutions that can govern effectively. The scope for assistance is limited only by the creativity of the donors.

As the newly elected government takes shape, the transatlantic partners will be in a position to influence, but not to determine, its decisions. In order to ensure a democratic system in which all Iraqis feel represented, it will be critical to bring the Sunnis into the political process. The Sunnis made a major mistake in boycotting the elections, but it is not a fatal error. There is wide scope for their participation in the constitutional drafting process, and there will be two further elections this year – the referendum on the constitution and the election of a permanent government. I am encouraged by strong signs that the Shiites and Kurds wish to reach out to the Sunnis, and we should urge Sunni leaders to join in the democratic process

In the Middle East many issues, both related and unrelated, are viewed through the prism of the Israeli-Palestinian conflict. Achieving peace between these two peoples would have positive reverberations throughout the region and the world, and today I believe that the potential for a permanent peace is closer than it has been in years. In Mahmoud Abbas, Israel finally has a real interlocutor with whom to talk. But the Palestinian economy and political system are shattered, and to return to the Roadmap, the Palestinians will require international help. We can assist the Palestinians as they build the institutions of an independent state and reject the pernicious role of terrorism in their society. Here too, NATO may have a key role. While I believe a peacekeeping role would serve only to prolong the necessary peace*making*, and should be avoided, there are other options for NATO participation, including training of security forces, enhancing border security, and monitoring the implementation of Roadmap commitments.

As we work to enhance security in the broader region, we will inevitably confront Iran's nuclear weapons program, the pursuit of which should alarm

us all. A longstanding sponsor of international terrorism, the radical Iranian regime defines itself by hostility to the United States and Israel. The United States needs to vigorously support European leadership on this issue, but our European friends must also realize that no deal will be worthwhile unless it includes a verifiable monitoring regime. And the mullahs running Iran's repressive regime should hear one unified message from all of us: continued nuclear weapons development will be punished by multilateral sanctions imposed by the United Nations Security Council. At the same time, the reformers and the millions of Iranians who aspire to self-determination must know that we support their longing for freedom and democracy.

Just as the desire for freedom is universal, so must be its promotion. It is not America's mission alone, nor Europe's – the people of the Middle East must seek freedom and democracy of their own accord. And as we look to nations like Iran, we see those eager for assistance and change. And governments like those in Iraq, Bahrain, Morocco, and Jordan hear their people and pursue reform. But we also see other governments, including longstanding friends, who invoke the specter of social chaos and undue foreign influence when faced with the most basic reform proposals. Egypt and Saudi Arabia, in many ways the pillars of the Arab world, could lead the Middle East into a new era, but they prefer to couple repression with a blind eye to the radicalism growing in their own societies.

In Egypt today, a degree of economic reform has taken hold, taxes are being cut, and growth is up. Yet President Mubarak has reigned as a dictator for almost 24 years, and he seeks yet another term, while grooming his son for what one newspaper described as a "Pharonic succession." To be clear, Egypt's support for Middle East peace is welcome, and critical. And yet when multiparty elections are doomed, opposition party leaders are jailed, and emergency laws remain in place for decades, we can no longer ignore its dangerous domestic environment. Egypt's reform plans, while clearly insufficient, are leagues ahead of Saudi Arabia, where elections will soon be held to fill municipal counsel seats. This is a welcome change to the absolute rule of the House of Saud, but repression remains the norm in that land. I single out Egypt and Saudi Arabia because these two proud countries should be the Middle East's natural leaders, but I could make similar remarks about other nations. If these governments are willing to reform, we should help them. If they refuse, and continue in their dangerous ways, we should reassess our relationships - including the billions of dollars in bilateral aid that flows to them.

U.S.-European cooperation on this issue is vital, and we have seen its success elsewhere. Afghanistan is a prime example. Ruled by the Taliban just four years ago, we have brought increasing stability, seen the return of over two million refugees, and witnessed a quiet democratic revolution in a land previously known only for its poverty, misrule, and violence. To further deepen our transatlantic cooperation there, we should combine the two separate operations – ISAF, under NATO command, and Operation Enduring Freedom, under U.S. command. By merging these under one NATO umbrella, we can enhance our alliance's sense of collective action and common purpose.

Ultimately, what we may need in the Middle East is a regional security structure, perhaps an institutionalized forum at which security issues can be addressed and rules of behavior hammered out. One model for such a grouping might be the ASEAN association of Southeast Asian countries. Over time, such a grouping might engage in arms control, develop norms for regional behavior, and exchange information on borders and transnational security threats, including terrorist groups. Given the deep political fissures in the Middle East today, we should not hope for too much too fast from such a structure, nor formalize it quickly as another talk shop. Yet some basic security architecture could help stabilize a region still feeling reverberations from various conflicts of years past.

While this talk pertains to security in the broader Middle East, I would like to touch briefly on events in the wider European neighborhood. The Rose Revolution in Georgia, progress in the western Balkans, and the recent events in Ukraine all suggest that democracy and freedom are marching forward. Yet under President Vladimir Putin, Russia is actually moving backward. Mr. Putin has moved to eliminate the popular election of Russia's 89 regional governors, has cracked down on independent media, continued his repression of business executives who oppose his government, and is reasserting the Kremlin's old-style central control. Most recently, Russia embraced electoral fraud in Ukraine and is now refusing to renew the mandate for the OSCE's border monitoring operation in Georgia – while at the same time complaining about alleged terrorist infiltration from Georgian territory. NATO can play a role here too, by taking over the border monitoring operation and ensuring that all observers are impartial, not subject to a Russian "nyet." (I see the Georgian Ministers of Defense and Foreign Affairs in the audience, and I would like to offer my sincere

condolences on the tragic passing of our friend, Prime Minister Zurab Zhavania.) The Atlantic democracies should commit to resolve Europe's frozen conflicts, which persist with Russian support, and together we should work with the people of Belarus to help end a dictatorship whose very existence offends Europe's values.

I have outlined a number of ways that NATO, the U.S. and the EU can use their power to enhance the security of the broader Middle East. In doing so, we should not overlook Europe's "soft power," which was on proud display during Ukraine's Orange Revolution. By attracting nations to its club of prosperous democracies, the EU has prompted change all along its ever expanding border. Perhaps it is time for the EU to consider a new mechanism for a close long-term partnership with Middle East democracies, beyond the Barcelona Process and the G-8 initiatives, as they arise. While it may be unrealistic to think that the European Union itself will stretch throughout the broader Middle East, some form of economic and security association would likely prompt more countries to make necessary reforms.

Europe and the United States are natural and vital partners, and so we cannot treat our relations today as merely a good faith effort to make the best of a bad situation. The opportunities we face are too numerous, and the challenges too grave, to limit our potential cooperation. President Harry Truman observed that, "Men make history, not the other way around. In periods where there is no leadership, society stands still. Progress occurs when courageous, skillful leaders seize the opportunity to change things for the better." In this room today we have many of these skillful leaders, and the opportunity for change now presents itself. When the United States and the countries of Europe stand together, it creates a moral and political force that gives no ground to the enemies of freedom. The world needs us together, and we need each other.

Smaller Fixes Could Bolster Social Security - AARP

WASHINGTON (Reuters) - The U.S. retirement system does not need a major overhaul or private accounts and can be stabilized through a series of smaller fixes, the nation's largest lobby group for the elderly said on Wednesday.

The AARP, formerly known as the American Association for Retired Persons, said the amount of wages that can be taxed for Social Security should be raised from \$90,000 to \$140,000. The change could be phased in over about 10 years and would cut the projected shortfall by 43 percent.

The government should also diversify investments for the fund that pays out the benefit to include a total market index fund that would yield a higher return, according to the group. That could reduce the shortfall by about 15 percent.

"Social Security does not need a radical overhaul," AARP Chief Executive Officer William Novelli said in remarks prepared for a National Press Club speech. "Reasonable steps such as these, including possibly adjusting benefits, are enough to strengthen Social Security for the long term."

. President Bush has called for a broad overhaul of the 70-year-old Social Security program, and has made adding private retirement accounts to the system his top domestic priority.

Bush has argued the program is headed into a financial crisis, a characterization Democrats, and some of Bush's fellow Republicans, say exaggerates the problem.

AARP and others, including Democrats and some Republicans, oppose such privatization as too risky.

"Taking money out of Social Security payroll taxes for private investment accounts would worsen the solvency outlook rather than improve it, and could lead to large benefit cuts," Novelli said.

Improvements should also be made to other private retirement accounts, including 401(k) and individual retirement accounts or IRAs, but such savings are needed in addition to Social Security, not instead of the program, he said.

Novelli also called for a series of changes to bolster Medicaid, the jointly funded federal and state health insurance program for the poor.

Health and Human Services Secretary Mike Leavitt has called the program, which serves about 52 million Americans, inefficient. The Bush administration's budget request released on Monday called for a slowdown in Medicaid spending of \$45 billion over 10 years.

Novelli agreed with some of the administrations plans to reduce costs, including buying

 prescription medicines more cheaply and allowing patients to receive home care instead of more costly care in nursing homes.

Focusing on preventive care would also keep people healthier and save money, he said.

Some proposals have suggested capping the amount of federal money for Medicaid or turning part of the program into a block grant system, both of which the AARP opposes.



Romney vs. Harvard

Is the Bay State a make-or-break point for the Culture of Life?

t's about saving lives and helping children."

That's usually the starting point for any conversation on stem-cell research and cloning. (It all generally gets muddled from there, once people start talking scientific and moral specifics they often don't understand.) Proponents of embryonic-stem-cell research and cloning want to help; opponents don't care about sick people. On the surface, it's pretty clear which side *everyone* instinctually wants to be on there. And that's the set-up in Massachusetts, circa right now: It's how the state senate's president, Robert Travaglini, set the debate at an emotional press conference on Thursday.

Earlier that morning, <u>via the New York Times</u>, Massachusetts Governor Mitt Romney stole a little thunder from determined human-cloning advocates at Harvard and in the Massachusetts statehouse. On Wednesday, Travaglini had introduced a bill that would allow government and privately funded embryonicstem-cell research and so-called "therapeutic" cloning in the Bay State. Romney announced that he would oppose any legislation that would allow for the creation of new human embryos for scientific experiments. He told the *Times* that "Some of the practices that Harvard and probably other institutions in Massachusetts are engaged in cross the line of ethical conduct."

Travaglini, cloning-advocates' point man in the state senate, quickly got the Boston media back on topic later in the day: "[T]he goal" of his legislation "is to save lives," he said at his press conference. None of Travaglini's over-the-top panacea rhetoric, however, was as effective as the activist mother of a young girl he invited to speak, who pulled, understandably, at the heartstrings. Her daughter is "a slave to illness" — chronic diabetes. We learned about her daughter's painful life:

She has had a medical appointment every two hours of her life for the past eight years. Her fingertips are shredded from 30,000 times that she has pricked her finger. She has been in the hospital critically ill 14 times. If you saw her, you would never know it. She smiles. She's happy. She's a straight-A student. That's because she has hope. And I'll tell you that a lot of that hope has to do with stem-cell research.

That is, embryonic-stem-cell-research.

But that emotional framing of the debate is disingenuous for a few reasons, the first being that the governor has presented a compromise position: In a non-ideal (from the pro-life vantage point) but pragmatic compromise move, Romney has decided to support experimentation on surplus frozen embryos from in-vitro fertilization procedures. But proponents of embryonic-stem-cell research refuse to meet him there. They want it all.

As Romney put it in a press conference on Thursday, "All of the rhetoric has been, 'We are throwing away embryos — surplus embryos — that could be used for stem-cell research and that makes no sense.'... And now, now that I've said, 'Ok, I support that,' now [the other side says], 'No, that's insufficient. How could you possibly limit it to that?' Well, that's what they've been asking for."

In other words, Romney has called their bluff.

As Travaglini said Thursday: "We should do everything we can to make sure it happens here." But his "it" is unnecessarily extreme. On the very same day, in fact, in the pages of his hometown paper, the *Boston Globe*, it was <u>reported</u> that University of California at San Diego researchers had discovered "cells in the heart that can create new muscle cells, raising hopes that doctors may find dramatic new ways to treat heart disease, the nation's leading cause of death." Not uncharacteristic of the stem-cell debate writ large, the big-money and big-mouth voices behind "stem-cell research" are narrowly focused on embryos, not on the available — and in many cases more promising — alternatives.

Hearings are expected in the Massachusetts statehouse on Wednesday of next week and will draw a parade of emotion, including expected testimony from hometown favorite <u>Travis Roy</u>, a former Boston University athlete whose hockey career was ended by a freak accident during his first college game. Ray would speak in favor of legal embryonic-stem-cell research and cloning.

Romney himself, however, is in a unique position for a politician facing this issue — and for that reason perhaps one of the best spokesmen for his side in the state. His wife, Ann, who he is not shy to say is one of his key advisers on these ethical issues, has M.S. So the hope of stem-cell research is one that hits close to home for the governor — and, tactically, takes some of the sting away from the usual "heartless Republican" accusation hurled by proponents of the all-or-nothing approach.

At the moment the Romney team has got to hang many of its legislative hopes on undecided/willing-to-be-persuaded legislators who could help build a strangebedfellow coalition. In terms of statewide support, the Mormon Romney's most obvious ally may be Massachusetts Catholics, who were with him on gay marriage, and will likely be with him again on the stem-cells and cloning big picture. (Forty-nine percent of Catholics, by the way, voted for Bush in November — up 17 points from 2000, in no doubt part influenced by the marriage debate.)

But it's going to be an uphill battle nonetheless for Romney. And the stakes are high, even aside from the intensely personal aspect of the issue for the Romneys. For a governor who is buzzed about as a potential 2008 presidential contender, Romney vs. Harvard could set not only his political fate but a significant precedent in a country that currently has no restrictions on embryonic-stem-cell research or cloning. With a cloning prohibition not on the schedule in the near future in the U.S. Capitol, and with California and New Jersey having already green lighted state-funded cloning, Massachusetts may be the primary battleground for Brave New World policymaking in the coming months.

Romney has started out of the gates playing it straight. "I am in favor of stemcell research. I am not in favor of creating new human embryos through cloning," he told the press on Thursday. Whether honesty will be enough to get him a coalition that will support a ban on cloning or sustain a veto of the Harvard wish list remains to be seen. The implications of failure, however, are crystal clear.
