On behalf of President Bush, thank you for your message concerning prosecution of fraud cases in connection with failed savings and loan institutions.

Working closely with the Congress, he has succeeded in obtaining many significant regulatory reforms. Last year, for example, the Department won fraud convictions against 791 major financial institutions, involving losses of over \$100,000 per case. The Federal Deposit Insurance Corporation also is pursuing more than 1,200 cases of fraud and negligence against thrift officials and has collected more than \$120 million in damages this year.
