We were very pleased and thankful for your decision, announced last night, regarding embryonic stem cell research. You honored your campaign pledge not to fund investigative work that would result in the deaths of tiny human babies. That was an answer to prayer for millions of your constituents.

I heard your remarks as I sat before the cameras waiting to talk to Larry King. Karl Rove had given me a heads up call, thankfully, just five minutes before air time. I can't tell you how relieved all of us were that you held the line on the defense of life, and by your articulate and persuasive explanation of the issue. We are concerned, however, about the possibility that the scientific community will "come back for more" after seeing within this decision an opening to be exploited. It is our prayer that you will meet those demands with the same resolve that was evident this week.

Thank you again, Mr. President, for your courageous decision. Though some conservatives have expressed strong disagreement, I am writing today to applaud the position you have taken.
