Good morning.

America is determined to enforce the demands of the United Nations Security Council, by confronting the grave and growing danger of Saddam Hussein and his weapons of mass destruction. This dictator will not be allowed to intimidate and blackmail the civilized world, or to supply his terrible weapons to terrorist groups, who would not hesitate to use them against us.

The safety of the American people depends on ending this threat. But America's cause is always larger than America's security. We also stand for the advance of freedom, opportunity, and hope. The lives and freedom of the Iraqi people matter little to Saddam Hussein – but they matter greatly to us.

Saddam Hussein has a long history of brutal crimes, especially in time of war – even against his own citizens. If conflict comes, he could target civilians or place them inside military facilities. He could encourage ethnic violence. He could destroy natural resources. Or, worst of all, he could use his weapons of mass destruction.

In order to minimize the suffering of Iraq's people, the United States and our coalition partners stand ready to provide vital help. We will deliver medicine to the sick, and make sure that Iraq's 55,000 food distribution sites, operating with supplies from the oil-for-food program, are stocked and open as soon as possible. We are stockpiling relief supplies, such as blankets and water containers, for one million people. We are moving into place nearly three million emergency rations to feed the hungry. The United States and Great Britain are providing tens of millions of dollars to the UN High Commissioner for Refugees, and to such groups as the World Food Program and UNICEF, so they will be ready to provide emergency aid to the Iraqi people.

We will also lead in carrying out the urgent and dangerous work of destroying chemical and biological weapons. We will provide security against those who try to spread chaos, or settle scores, or threaten the

territorial integrity of Iraq. We will seek to protect Iraq's natural resources from sabotage by a dying regime – and ensure they are used for the benefit of Iraq's own people.

The United States has no intention of determining the precise form of Iraq's new government. That choice belongs to the Iraqi people. Yet we will ensure that one brutal dictator is not replaced by another. All Iraqis must have a voice in the new government, and all citizens must have their rights protected.

Rebuilding Iraq will require a sustained commitment from many nations, including our own: We will remain in Iraq as long as necessary, and not a day more. America has made and kept this kind of commitment before – in the peace that followed World War Two. After defeating enemies, we did not leave behind occupying armies, we left constitutions and parliaments. We did not leave behind permanent foes; we found new friends and allies.

There was a time when many said that the cultures of Japan and Germany were incapable of sustaining democratic values. They were wrong. Some say the same of Iraq today. They, too, are mistaken. The nation of Iraq – with its proud heritage, abundant resources, and skilled, educated people – is fully capable of moving toward democracy and living in freedom.

It will be difficult to help freedom take hold in a country that has known three decades of dictatorship, secret police, internal divisions, and war. Yet the security of our Nation and the hopes of millions depend on us, and Americans do not turn away from duties because they are hard. We have met great tests in other times, and we will meet the tests of our time.

I. PURPOSE

To highlight your Administration's successes in homeland security as well as your vision for the future of homeland security.

II. BACKGROUND

This Saturday, March 1, 2003, is an important milestone in your Administration's efforts to secure the homeland. Secretary Ridge will assume control of all but one of the 22 Federal agencies being transferred to the Department of Homeland Security (Plum Island Animal Disease Center transfers on June 1). With the transfer, Secretary Ridge will assume operational responsibility for the vast majority of the Department's missions, effecting the most significant reorganization of the Federal Government in over 50 years.

Among the agencies transferring on Saturday are the U.S. Coast Guard, the U.S. Secret Service, the U.S. Customs Service, the Transportation Security Administration, the functions of the Immigration and Naturalization Service, the U.S. Border Patrol, the Federal Emergency Management Agency, the Federal Protective Service, and a number of other specialized agencies.

The Administration has taken a variety of actions to ensure a smooth and effective transition and ensure continuity of homeland security and other services. They include Secretary Ridge's decision to reorganize the Department's Border and Transportation Security Directorate; initial stand-up of the Department's 24/7 operations center at the Nebraska Avenue facility; completion for your consideration of an Executive Order directing necessary actions associated with the March 1 transfer of responsibilities (a copy is attached); and completion for your consideration of a new Presidential Directive providing guidance on Secretary Ridge's unprecedented responsibilities as the principal Federal official for domestic incident management.

The world changed on September 11, 2001. We learned that a threat that gathers on the other side of the earth can strike our own cities and kill our own citizens. Oceans no longer protect America from the dangers of the world. We are protected by daily vigilance at home, and resolute action against threats abroad. We are tracking down the terrorists one by one. We are opposing terror regimes that are arming to threaten the peace of the world. And we are taking unprecedented measures to defend the homeland, with the largest reorganization of our government in more than half a century.

The agencies that join the Department of Homeland Security tomorrow will retain their longstanding responsibilities, and the individuals who join the Department will retain their rights as federal workers. Each agency, with its own proud and honored traditions, will also gain a new mandate, and must adopt a new mindset. We created this Cabinet Department in a time of war. And every professional in the Department of Homeland Security plays a valuable role in winning the first war of the 21st century.

For a vast and free nation, there is no such thing as perfect security from a hidden network of killers. Yet we are determined to do everything in our power to defeat this enemy, and to defend our people, while upholding our Constitution. We have taken some critical steps to increase homeland security, and there is more work for this department to do.

The Department of Homeland Security is charged with analyzing the vulnerabilities of our Nation's critical infrastructure – from dams to banks to seaports. And when our intelligence agencies learn of new threats, the Department will move quickly to take protective action.

In meeting this responsibility, the Department will be a full partner in the new Terrorist Threat Integration Center, which will integrate and analyze all threat information, collected domestically and abroad, in a single location. When the center is fully operational, it will fully house a

database of known and suspected terrorists that officials across the country will be able to access and act upon. In these and other efforts, the FBI and the CIA are communicating and cooperating as never before. The FBI has made preventing terrorism its top priority and increased agents assigned to counterterror efforts by nearly 40 percent.

The Department of Homeland Security is also charged with strengthening our defenses against cyberterrorism, and the even greater dangers of biological, chemical, and nuclear weapons.

We have established a Science and Technology directorate within the Department, so we can apply some of our Nation's best minds to the task of protecting our people. I have nominated a good man, Dr. Charles McQueary, to head up this effort. His team is engaged in a major effort to develop and deploy the technologies for detecting weapons of mass destruction. As these technologies are deployed, border inspectors will have better tools to intercept dangerous materials before they enter our country. Emergency services personnel will be able to identify biological or chemical agents, so they can use the most effective decontamination methods. And as part of the BioWatch Initiative, we are deploying early warning sensors around the country to help detect potential biological attacks.

This week, I sent to Congress my proposal for Project BioShield, a major research and production effort to guard our people against bioterrorism. I have requested nearly six billion dollars for this project, to quickly make available effective vaccines and treatments against agents like anthrax, botulinum toxin, Ebola, and plague. We must assume that our enemies would use these diseases as weapons, and we must act before the dangers are upon us. I urge the Congress to pass this legislation as soon as possible.

The Department of Homeland Security is charged with promoting cooperation between Washington and state and local governments. Our enemies could strike anywhere in America, and we must be ready to respond in a coordinated way. And we are moving forward.

Through the Homeland Security Advisory System, we have created a unified process for alerting government officials and the public of current threats. We are also providing more information about suspected terrorists

to state and local law enforcement agencies. And with this new Department, state and local officials will now have a single point of contact to assist them.

The Department of Homeland Security is charged with safeguarding our border and transportation systems. September 11th taught us that terrorists will try to use the openness of our country against us. We must understand and correct our vulnerabilities, and we need to know who is coming in and going out of our country.

We are working with our good friends Canada and Mexico to strengthen our law enforcement at the borders. The Transportation Security Administration has assigned thousands of air marshals to commercial flights and deployed more than 50,000 newly trained airport screeners. TSA is also screening all checked luggage at our airports, up from 5 percent before September 11, 2001.

Starting tomorrow, four different organizations that patrol and enforce laws at our borders will be integrated into a new Bureau of Customs and Border Protection. This Bureau will unify border inspection and enforcement functions, so that legitimate visitors and goods can enter the United States, while giving us better tools to help deny entry to terrorists, drug traffickers, and dangerous materials. Inspectors will be posted at more than 20 ports around the world, to examine high risk cargo before it sets sail for our country.

The new Department is charged with responding to any terror attack that may come. And we are moving forward on essential preparations.

Over the past 18 months, we have significantly enhanced our national stockpile of critical drugs, vaccines, and other medical supplies. Supplies from this stockpile can be delivered wherever they are needed, anywhere in the country, within 12 hours. We have provided more than 900 million dollars in support to help state and local responders and emergency managers prepare for terrorist attacks. And we have supported the training of more than 100,000 first responders since September 11, 2001.

I proposed record funding for first responders – 3.5 billion dollars in the current budget. I have also requested another 3.5 billion in the 2004

budget. Unfortunately, the Congress was late passing an appropriations bill for 2003. They reduced my total request for state and local law enforcement and emergency personnel by one billion dollars, and designated part of the funding to go toward other priorities.

I signed the appropriations bill to make sure we can finally begin to distribute funding to states. The leaders of the House and Senate are aware of my concerns and share them. These leaders know that I will continue to do everything in my power to direct as much of this funding as possible toward training and equipping police, firefighters, and EMTs to prepare for and respond to potential terrorist attacks.

Beginning tomorrow, the Department of Homeland Security will be responsible for coordinating our national response to terrorist attacks. Secretary Ridge has already created a 24/7 Homeland Security Center, ready to act at the first sign of emergency. And I will be issuing a directive ordering the establishment of a unified National Incident Management System. This system will provide government agencies with common procedures and standards for preparing, and responding, to emergencies.

Our Nation has great challenges in securing our homeland. And we have even greater advantages. We have people like all of you, who serve with great skill, and do not get much attention for the vital work you do. We have brave and honorable men and women serving in the military, including the Coast Guard, ready to accomplish every mission we give them. Above all, we have the courage and character of the American people, who are resolved to prevent further attacks on our homeland.

March 1st marks an important day for our government and our country. The work ahead will not always be easy. You have accepted a difficult mission. But I am confident in the success of our efforts, because I am confident in you. I thank each of you for your service in freedom's cause.

God bless you all, and God bless America.

HOMELAND SECURITY PRESIDENTIAL DIRECTIVE/HSPD - 5

Subject: Management of Domestic Incidents

Purpose

(1) To enhance the ability of the United States to manage domestic incidents by establishing a single, comprehensive national incident management system.

Definitions

(2) In this directive:

(a) the term "Secretary" means the Secretary of Homeland Security.

(b) the term "federal departments and agencies" means those executive departments enumerated in 5 USC 101, together with the Department of Homeland Security; independent establishments as defined by 5 USC 104(1); government corporations as defined by 5 USC 103(1); and the United States Postal Service.

(c) the terms "State," "local," and the "United States" when it is used in a geographical sense, have the same meanings as used in the Homeland Security Act of 2002, Public Law 107-296.

Policy

(3) To prevent, prepare for, respond to, and recover from terrorist attacks, major disasters, and other emergencies, the United States Government shall establish a single, comprehensive approach to domestic incident management. The objective of the United States Government is to ensure that all levels of government across the Nation have the capability to work efficiently and effectively together, using a national approach to domestic incident management. In these efforts, with regard to domestic incidents, the United States Government treats crisis management and consequence management as a single, integrated function, rather than as two separate functions.

(4) The Secretary of Homeland Security is the principal federal official for domestic incident management. Pursuant to the Homeland Security Act of 2002, the Secretary is responsible for coordinating federal operations within the United States to prepare for, respond to, and recover from terrorist attacks, major disasters, and other emergencies. The Secretary shall coordinate the federal government's resources utilized in response to or recovery from terrorist attacks, major disasters, or other emergencies if and when any one of the following four conditions applies: (1) a federal department or agency acting under its own authority has requested the assistance of the Secretary; (2) the resources of State and local authorities are overwhelmed *and* federal assistance has been requested by the appropriate State and local authorities; (3) more than one federal department or agency has become substantially involved in responding to the incident; or (4) the

Secretary has been directed to assume responsibility for managing the domestic incident by the President.

(5) Nothing in this directive alters, or impedes the ability to carry out, the authorities of federal departments and agencies to perform their responsibilities under law. All federal departments and agencies shall cooperate with the Secretary in the Secretary's domestic incident management role.

(6) The federal government recognizes the roles and responsibilities of State and local authorities in domestic incident management. Initial responsibility for managing domestic incidents generally falls on State and local authorities. The federal government will assist State and local authorities when their resources are overwhelmed, or when federal interests are involved. The Secretary will coordinate with State and local governments to ensure adequate planning, equipment, training, and exercise activities. The Secretary will also provide assistance to State and local governments to develop all-hazards plans and capabilities, including those of greatest importance to the security of the United States, and will ensure that State, local, and federal plans are compatible.

(7) The federal government recognizes the role that the private and non-governmental sectors play in preventing, preparing for, responding to, and recovering from terrorist attacks, major disasters, and other emergencies. The Secretary will coordinate with the private and non-governmental sectors to ensure adequate planning, equipment, training, and exercise activities and to promote partnerships to address incident management capabilities.

(8) The Attorney General has lead responsibility for criminal investigations of terrorist acts or terrorist threats by individual(s) or group(s) inside the United States, or directed at United States citizens or institutions abroad, where such acts are within the federal criminal jurisdiction of the United States, as well as for related intelligence collection activities within the United States, subject to the National Security Act of 1947 and other applicable law, Executive Order 12333, and Attorney General-approved procedures pursuant to that Executive Order. Generally acting through the Federal Bureau of Investigation, the Attorney General, in cooperation with other United States Government departments and agencies engaged in activities to protect our national security, shall also coordinate the activities of the other members of the law enforcement community to detect, prevent, preempt, and disrupt terrorist attacks against the United States. Following a terrorist threat or an actual incident that falls within the criminal jurisdiction of the United States, the full capabilities of the United States shall be dedicated, consistent with United States law and with activities of other U.S. Government departments and agencies to protect our national security, to assisting the Attorney General to identify the perpetrators and bring them to justice. The Attorney General and the Secretary shall establish appropriate relationships and mechanisms for cooperation and coordination between their two departments.

(9) Nothing in this directive impairs or otherwise affects the authority of the Secretary of Defense over the Department of Defense, including the chain of command for military forces from the President as Commander in Chief, to the Secretary of Defense, to the commander of military forces or military command and control procedures. The Secretary of Defense shall provide military support to civil authorities for domestic incidents as directed by the President or

when consistent with military readiness and appropriate under the circumstances and the law. The Secretary of Defense shall retain command of military forces providing civil support. The Secretary of Defense and the Secretary shall establish appropriate relationships and mechanisms for cooperation and coordination between their two departments.

(10) The Secretary of State has the responsibility, consistent with other United States Government activities to protect our national security, to coordinate international activities related to the prevention, preparation, response, and recovery from a domestic incident, and for the protection of United States citizens and United States interests overseas. The Secretary of State and the Secretary shall establish appropriate relationships and mechanisms for cooperation and coordination between their two departments.

(11) The Assistant to the President for Homeland Security and the Assistant to the President for National Security Affairs shall be responsible for interagency policy coordination on domestic and international incident management, respectively, as directed by the President. The Assistant to the President for Homeland Security and the Assistant to the President for National Security Affairs shall work together to ensure that the United States' domestic and international incident management efforts are seamlessly united.

(12) The Secretary shall ensure that, as appropriate, information related to domestic incidents is gathered and provided to the public, the private sector, State and local authorities, federal departments and agencies, and, generally through the Assistant to the President for Homeland Security, to the President. The Secretary shall provide standardized, quantitative reports to the Assistant to the President for Homeland Security on the readiness and preparedness of the Nation – at all levels of government – to prevent, prepare for, respond to, and recover from domestic incidents.

(13) Nothing in this directive shall be construed to grant to any Assistant to the President any authority to issue orders to federal departments and agencies, their officers, or their employees.

Tasking

(14) The heads of all federal departments and agencies are directed to provide their full and prompt cooperation, resources, and support, as appropriate and consistent with their own responsibilities for protecting our national security, to the Secretary, the Attorney General, the Secretary of Defense, and the Secretary of State in the exercise of the individual leadership responsibilities and missions assigned in paragraphs (4), (8), (9), and (10), respectively, above.

(15) The Secretary shall develop, submit for review to the Homeland Security Council, and administer a National Incident Management System (NIMS). This system will provide a consistent nationwide approach for federal, State, and local governments to work effectively and efficiently together to prepare for, respond to, and recover from domestic incidents, regardless of cause, size, or complexity. To provide for interoperability and compatibility among federal, State, and local capabilities, the NIMS will include a core set of concepts, principles, terminology, and technologies covering the incident command system; multi-agency coordination systems; unified command; training; identification and management of resources

(including systems for classifying types of resources); qualifications and certification; and the collection, tracking, and reporting of incident information and incident resources.

(16) The Secretary shall develop, submit for review to the Homeland Security Council, and administer a National Response Plan (NRP). The Secretary shall consult with the [[Science Advisor to the President]] and the Assistant to the President for Economic Policy, and other such advisors in developing and implementing the NRP. This plan shall integrate federal government domestic prevention, preparedness, response, and recovery plans into one all-discipline, all-hazards plan. The NRP shall be unclassified. If certain operational aspects require classification, they shall be included in classified annexes to the NRP.

- (a) The NRP, using the NIMS, shall, with regard to response to domestic incidents, provide the structure and mechanisms for national level policy and operational direction for federal support to State and local incident managers and for exercising direct federal authorities and responsibilities, as appropriate.
- (b) The NRP will include protocols for operating under different threats or threat levels; incorporation of existing federal emergency and incident management plans (with appropriate modifications and revisions) as either integrated components of the NRP or as supporting operational plans; and additional operational plans or annexes, as appropriate, including public affairs and intergovernmental communications.
- (c) The NRP will include a consistent approach to reporting incidents, providing assessments, and making recommendations to the President, the Secretary, and the Homeland Security Council.
- (d) The NRP will include rigorous requirements for continuous improvements from testing, exercising, experience with incidents, and new information and technologies.

(17) The Secretary shall:

- (a) By April 1, 2003, (1) develop and publish an initial version of the NRP, in consultation with other federal departments and agencies; and (2) provide the Assistant to the President for Homeland Security with a plan for full development and implementation of the NRP.
- (b) By June 1, 2003, (1) in consultation with federal departments and agencies and with State and local governments, develop a national system of standards, guidelines, and protocols to implement the NIMS; and (2) establish a mechanism for ensuring ongoing management and maintenance of the NIMS, including regular consultation with other federal departments and agencies and with State and local governments.
- (c) By September 1, 2003, in consultation with federal departments and agencies and the Assistant to the President for Homeland Security, review existing authorities and regulations and prepare recommendations for the President on revisions necessary to implement fully the NRP.

(18) The heads of federal departments and agencies shall adopt the NIMS within their departments and agencies and shall provide support and assistance to the Secretary in the development and maintenance of the NIMS. All federal departments and agencies will use the NIMS in their domestic incident management and emergency prevention, preparedness, response, recovery, and mitigation activities, as well as those actions taken in support of State or local entities. The heads of federal departments and agencies shall participate in the NRP, shall assist and support the Secretary in the development and maintenance of the NRP, and shall participate in and use domestic incident reporting systems and protocols established by the Secretary.

(19) The head of each federal department and agency shall:

- (a) By June 1, 2003, make initial revisions to existing plans in accordance with the initial version of the NRP.
- (b) By August 1, 2003, submit a plan to adopt and implement the NIMS to the Secretary and the Assistant to the President for Homeland Security. The Assistant to the President for Homeland Security shall advise the President on whether such plans effectively implement the NIMS.

(20) Beginning in Fiscal Year 2005, federal departments and agencies shall make adoption of the NIMS a requirement, to the extent permitted by law, for providing federal preparedness assistance through grants, contracts, or other activities. The Secretary shall develop standards and guidelines for determining whether a State or local entity has adopted the NIMS.

Technical and Conforming Amendments to National Security Presidential Directive-1 (NSPD-1)

(21) NSPD-1 ("Organization of the National Security Council System") is amended by replacing the fifth sentence of the third paragraph on the first page with the following: "The Attorney General, the Secretary of Homeland Security, and the Director of the Office of Management and Budget shall be invited to attend meetings pertaining to their responsibilities."

Technical and Conforming Amendments to National Security Presidential Directive-8 (NSPD-8)

(22) NSPD-8 ("National Director and Deputy National Security Advisor for Combating Terrorism") is amended by striking "and the Office of Homeland Security," on page 4, and inserting "the Department of Homeland Security, and the Homeland Security Council" in lieu thereof.

Technical and Conforming Amendments to Homeland Security Presidential Directive-2 (HSPD-2)

(23) HSPD-2 (“Combating Terrorism Through Immigration Policies”) is amended as follows:

- (a) striking “the Commissioner of the Immigration and Naturalization Service (INS)” in the second sentence of the second paragraph in section 1, and inserting “the Secretary of Homeland Security” in lieu thereof;
- (b) striking “the INS,” in the third paragraph in section 1, and inserting “the Department of Homeland Security” in lieu thereof;
- (c) inserting “, the Secretary of Homeland Security,” after “The Attorney General” in the fourth paragraph in section 1;
- (d) inserting “, the Secretary of Homeland Security,” after “the Attorney General” in the fifth paragraph in section 1;
- (e) striking “the INS and the Customs Service” in the first sentence of the first paragraph of section 2, and inserting “the Department of Homeland Security” in lieu thereof;
- (f) striking “Customs and INS” in the first sentence of the second paragraph of section 2, and inserting “the Department of Homeland Security” in lieu thereof;
- (g) striking “the two agencies” in the second sentence of the second paragraph of section 2, and inserting “the Department of Homeland Security” in lieu thereof;
- (h) striking “the Secretary of the Treasury” wherever it appears in section 2, and inserting “the Secretary of Homeland Security” in lieu thereof;
- (i) inserting “, the Secretary of Homeland Security,” after “The Secretary of State” wherever the latter appears in section 3;
- (j) inserting “, the Department of Homeland Security,” after “the Department of State,” in the second sentence in the third paragraph in section 3;
- (k) inserting “the Secretary of Homeland Security,” after “the Secretary of State,” in the first sentence of the fifth paragraph of section 3;
- (l) striking “INS” in the first sentence of the sixth paragraph of section 3, and inserting “Department of Homeland Security” in lieu thereof;
- (m) striking “the Treasury” wherever it appears in section 4 and inserting “Homeland Security” in lieu thereof;

- (n) inserting “, the Secretary of Homeland Security,” after “the Attorney General” in the first sentence in section 5; and
- (o) inserting “, Homeland Security” after “State” in the first sentence of section 6.

Technical and Conforming Amendments to Homeland Security Presidential Directive-3 (HSPD-3)

(24) The Homeland Security Act of 2002 assigned the responsibility for administering the Homeland Security Advisory System to the Secretary of Homeland Security. Accordingly, HSPD-3 of March 12, 2002 ("Homeland Security Advisory System") is amended as follows:

- (a) replacing the third sentence of the second paragraph entitled “Homeland Security Advisory System” with “Except in exigent circumstances, the Secretary of Homeland Security shall seek the views of the Attorney General, and any other federal agency heads the Secretary deems appropriate, including other members of the Homeland Security Council, on the Threat Condition to be assigned.”
- (b) inserting “At the request of the Secretary of Homeland Security, the Department of Justice shall permit and facilitate the use of delivery systems administered or managed by the Department of Justice for the purposes of delivering threat information pursuant to the Homeland Security Advisory System.” as a new paragraph after the fifth paragraph of the section entitled “Homeland Security Advisory System.”
- (c) inserting “, the Secretary of Homeland Security” after “The Director of Central Intelligence” in the first sentence of the seventh paragraph of the section entitled “Homeland Security Advisory System”
- (d) striking “Attorney General” wherever it appears (except in the sentences referred to in subsections (a) and (c) above), and inserting “the Secretary of Homeland Security” in lieu thereof; and
- (e) striking the section entitled “Comment and Review Periods.”

Michael Steele

Lieutenant Governor Steele is the first African-American to serve as Lieutenant Governor in Maryland's history. He graduated from Johns Hopkins University with a B.A. in International Relations and was the student body president. He then enrolled at Villanova University, Augustinian Order, but left Villanova to pursue a J.D. from Georgetown University Law School, which he completed in 1991.

Jackie Winters

State Senator Winters represents Senate District 10 (Salem, Oregon). She is the owner of a small business called "Jackie's Ribs-Catering." She attended Jefferson High School in Portland, Oregon, and participated in the Oregon State University Extension program.

James Garner

Hempstead Village Mayor Garner became Long Island's first African-American Mayor when he was elected in 1989. Prior to that, he served one term on the Hempstead Village Board of Trustees. He will also become the President of the U.S. Conference of Mayors in 2003. Mayor Garner holds a B.S. from Adelphi University.

Michael Williams

You appointed Michael Williams to the Texas Railroad Commission in December 1998, to serve the unexpired term of Carole Keeton Rylander. He was elected by his fellow commissioners in September 1999 to chair the Commission, and in November 2000 the people of Texas elected him to complete the term expiring in the year 2002. He was reelected Texas Railroad Commissioner in November 2002 and will serve until 2008. He is the first African-American in Texas history to hold a statewide executive post and is the highest ranking African-American in Texas state government.

Pearl Burris-Floyd

Commissioner Burris-Floyd is a graduate of East Gaston High School in North Carolina. She was elected Gaston County's first African-American County Commissioner. She runs a cancer detection center in Hickory. She received a bachelor's degree from UNC Chapel Hill and certification as a cytologist at the UNC School of Medicine. She is pursuing a master's degree in business administration from UNC Charlotte.

Dorothy Height

Dr. Height has served as president of the National Council of Negro Women for over 40 years. She was born in 1912 in Richmond, Virginia, and educated in the public schools of Rankin, Pennsylvania. At the age of 25, she heeded the call of Mary McLeod Bethune, founder of the National Council of Negro Women, to join her in her quest for women's full and equal employment and educational advancement. She went on to become one of the major leaders of the Civil Rights Movement of the 1960s. She also began, at a young age, her work with the National Young Women's Christian Association (YWCA) of the USA. Dr. Height is credited with developing the strategies to ensure the success of the YWCA's mission to provide equal opportunity and facilities for women of all cultures and nationalities. Her belief in honoring the diversity of America is seen in her promotion of interfaith, interracial, and ecumenical movements.

Keith Butler

Bishop Butler is the founder and pastor of Word of Faith International Christian Center, which has churches across the country. He also serves the Faith Christian Center in Phoenix, Arizona. With the support of his wife, Minister Deborah Butler, and their children – Pastor Keith Butler II and his wife Minister Tiffany, Minister Michelle Butler, and Minister Kristina Butler – Bishop Butler continues to expand his churches worldwide. He ministers extensively in churches, conferences, and seminars throughout the U.S. and abroad. His television outreach, “The Word of Faith,” is seen each week on television stations across the world.

Robert “Bob” Woodson, Sr.

Mr. Woodson is the founder and president of the National Center for Neighborhood Enterprise (NCNE). Often referred to as the “godfather” of the movement to empower neighborhood-based organizations, Bob Woodson’s social activism dates back to the 1960s when, as a young civil rights activist, he developed and coordinated national and local community development programs. During the 1970s he directed the National Urban League’s Administration of Justice division and then served as a Resident Fellow at the American Enterprise Institute.

Note: Rob Woodson, Mr. Woodson’s son, was involved in a fatal automobile accident on February 9, 2003, when his automobile hit an ice patch on a road and slid out of control. A memorial service was held at the New York Avenue Presbyterian Church on February 13, 2003. You called and wrote the family.

Video Taping: Small Business Administration 50th Anniversary

Thank you very much. I am pleased to speak to everyone at the Small Business Administration as you gather to celebrate 50 years of "Empowering America's Entrepreneurs." Hector knows what all of you know – that small businesses are the backbone of our economy.

There are 25 million small businesses today that are creating most of the new jobs in America. I salute the SBA for working to strengthen America's small businesses through its efforts to promote access to capital and reduce regulation.

You also know that my economic growth package will help more Americans find jobs by strengthening our economy and supporting small businesses. The tax relief already planned for later in this decade should be made effective this year. When Congress acts, I will direct the Treasury to return this money to taxpayers right away, which will provide immediate help to our economy.

What's interesting about tax relief is how it affects our small businesses. It's very important for our fellow citizens to know that many small business owners organize their businesses in such a way that they pay individual tax rates. A subchapter S corporation will pay tax at the individual tax rate. A limited partnership pays tax at the individual tax rate. A sole proprietorship pays tax at the individual tax rate. Most small businesses are organized in one of those three fashions. So when you hear me talk about individual tax rate cuts, I want you to think about its positive effect on small businesses all across America.

We also believe the tax code ought to be used to encourage people to make wise decisions in their businesses. A small business can only deduct up to 25,000 dollars in the year in which they make a capital purchase. So we believe that in order to encourage more investment – to encourage small business owners to buy more machines that make their business grow and produce – we ought to raise that limit to 75,000 dollars a year.

Under our plan, we estimate that 23 million small business owners across America will save an average 2,042 dollars from the income tax rate cut. And this will lead to small businesses investing in equipment, making new hires, and opening new offices. And that's why we believe the tax relief plan will create 1.4 million new jobs by the end of 2004.

That's good news for our economy. And that's a good reason why Congress needs to pass this plan right away.

Thanks again for all your fine work. Congratulations on your 50th Anniversary. May God bless you. And may God continue to bless America.
