### I. PURPOSE

To light the National Christmas Tree.

### II. BACKGROUND

Since the Coolidge Administration, every President has participated in the lighting of the National Christmas Tree. This tree lighting event is coordinated by the Christmas Pageant of Peace, Inc., which is a non-profit organization consisting of local community and civic leaders, as well as the National Park Service. This will be the 82<sup>nd</sup> year this event has occurred.

Jackie (14), Melissa (11), and Jenna (8) Kantor of Bethesda, Maryland, have been chosen by Mrs. Bush's office and the Visitor's Office to assist in lighting the tree. The sisters started "Project Backpack," a grassroots effort to give children displaced by Hurricane Katrina new backpacks filled with books, toys, and school supplies. The idea spread to more than 30 cities nationwide, and as far away as Australia. Within one month, over 25,000 backpacks were collected and distributed. The girls' parents, Steve and Aileen Kantor, will be seated in the audience along with grandparents, Jean Enoch and Lawrence Goldberg.

### Rev. Richard B. Martin, Pastor, Church of the Nativity, Burke, Virginia.



The invocation will be given by Rev. Richard B. Martin, Pastor, Church of the Nativity in Burke, Virginia. A native of Warwick, Rhode Island, Father Martin will celebrate 40 years as a Catholic priest in 2006. During that time, he has served as a chaplain in the U.S. Air Force, as a rehabilitation counselor for the U.S. government, and as parish priest and pastor to several congregations in the Richmond and Arlington Dioceses of Virginia. Perhaps his most significant service has been the establishment of "Operation Starfish," a humanitarian program serving the poor of the Caribbean and Latin America. Father Martin is known for his simple words of inspiration and comfort. His services are filled to overflowing with followers of all denominations. He reaches people wherever they are in life with a message of love, kindness and compassion and he does so with a great sense of humor.

### United States Navy Band



The United States Navy Band from Washington, D.C. is the Navy's premier musical representative. Under the direction of Captain Ralph M. Gambone, the Navy Band is recognized by many as "The World's Finest" and is staffed by some of the nation's best musicians. Established on March 4, 1925, by an Act of Congress, the Navy Band has participated in 20 presidential inaugurations and countless ceremonies at the White House, Pentagon, and Arlington National Cemetery. The Band performs public concerts frequently in the Washington metropolitan area and tours the country annually. The Navy Band occupies a position of national prominence as both a service tradition and a distinguished musical organization.

### Ricky Skaggs



Ricky Skaggs began performing at age five and earned his first paycheck for a musical performance at age seven. By age 15, he began a professional music career that led to 18 top-10 Billboard singles, with 12 of those singles reaching the #1 position. In 1982, Ricky was invited to join the world-famous Grand Ole Opry, the youngest member ever to be inducted at that time. Ricky has gone on to win numerous awards and recognition for his artistic talent. Skaggs' current album, *Brand New Strings*, won a Grammy in 2005 for "Best Bluegrass Album" – his 10th Grammy. This year, Ricky and the Skaggs family, joined by the Whites, one of America's most beloved family groups, have produced *A Skaggs Family Christmas, Vol. 1*. The idea of a Christmas show was born in the Skaggs family living room while singing traditional holiday songs. A CD and a Country Music Television special will bring this Skaggs family tradition into the homes of Americans across the country this Christmas.

## Maya Angelou



Maya Angelou was born Marguerite Johnson in St. Louis, Missouri, and grew up in a racially segregated part of Stamps, Arkansas. Maya Angelou grew up with great love and great hardships. As she recalls, folks who had "cotton" money and could afford fresh meat twice a month suddenly found they barely had anything at all to eat during the Depression years. But with her beloved grandmother, her mother Vivian, older brother Bailey, and Uncle Willie, Maya Angelou was surrounded by love. Maya Angelou is the author of 13 best-selling books, including her most recent, *Hallelujah! The Welcome Table*, a beautiful recipe book that gently sifts her favorite foods and fond memories in equal parts. She is also one of only two artists ever commissioned to write and recite an original work for a Presidential inauguration. Ms. Angelou goes from authoring poems to books to essays to short stories to inspirational messages, always with the theme of the universality of love and the human condition. "The honorary duty of a human being is to love," Angelou says.
