KINGSTON -- John Smith has over 400 children he calls his own.

No, he is not pictured on the pages of the Guinness Book of World Records.

He is the award winning music teacher in Kingston, Halifax, Plympton and Pembroke.

The Harvard chapter of Phi Delta Kappa recently honored Smith and 15 other finalists for the 2002 Wal-Mart Teacher of the Year Award.

But where the award came from, said Smith, is more important that the award itself. The nomination for the award didn't come from a committee or other teachers. Smith was nominated by one of his students, that's primo, that's the best," said Smith. "There is no political influence at all."

Smith's sixth grade students will be performing today at the Reed Community Center for the council on again senior luncheon sponsored by the police department.

When Mr. Smith is relaxing at home he enjoys listening to traditional classical music and new age music. In 10 years Mr. Smith sees himself physically fit, closer to God and hopefully having made an impact on more people through his mission of music.

It's going to be tough to say good bye to Mr. Smith when this year is over. He's been my teacher, my friend and a great influence to me. Because of him 1 plan to become a musical performer when I grow up. Maybe I, too, will get to play at Carnegie Hall. If I do, I hope Mr. Smith will be in the audience.

THE CHIEF OF STAFF HAS SEEN

Hi Andy,

Please read this through. It is worthwhile feedback.

Things out here are changing VERY fast – I support the President and admire his performance and accomplishments, but he is losing support at an incredibly fast rate. Something must happen soon – time is running out.

As a "supposed" communications expert I work with a great many Fortune 500 companies, and travel the country -- I speak with senior management in every sector, every day – from IBM and HP to Deloitte & Touche, Goldman Sachs and General Motors.

The financial pain threshold has been hit – people who I <u>never</u> thought would say a word against the President are now convinced the President is counting on the war (right or wrong) to divert attention from the "real enemy," the economy. People are hurting badly Andy – it has become very painful.

If you have ever read *Citizen Soldiers*, by Stephen Amros you'll remember the line: Thousands of Americans died because the Generals never visited the trenches to see the quagmire and mud that made advance impossible – the Generals then ordered an advance when advance was impossible.

I'm in the trenches Andy, you're at command headquarters -- please visit the trenches and speak with the troops. You have done this, I know, but no one thinks so.

It bothers me that the average senior manager and the average working guy has lost considerable interest in the enemy abroad because the enemy at home is perceived to be the greater threat. If anything, this is an understatement. People are no longer fence-sitting, torn 50/50, regardless of what the pollsters tell you.

Here's what most people I talk to believe:

-- Hussein has chemical and biological weapons, and wants nuclear weapons.

-- However, no direct connect with al Qaeda has been shown, Hussein is viewed as a regional threat, not a direct threat to the US.

-- Meanwhile the economy is worsening and is not being attended to while the focus is on an unneeded war -- or worse, a war needed only by Bush.

-- YET, Americans are furious over being hood-winked by Hussein for 12 years and want him gone.

-- Answer, let the other shoe drop so the economy can move forward, get the war done fast. We know the French and Russians have their own economic interests at heart, ours

come first – get the war done and get our economy on track. Business managers tell me they will not spend money until we are off the fence.

I praise the President's restraint to date, it's been remarkable – but it's time to piss or get off the pot. Personally I'm not sure what the right decision is, no one does, but I feel a decision has to be made fast. People are starting to feel that Bush isn't "protecting America," rather he's protecting himself -- we can't let that happen -- Andy you know what that's like, a 100,000 people can be dying in China from starvation, but the average guy is worried more about the wart that's growing on his nose, the wart is perceived to have an direct and immediate affect.

Dear Andy,

I will not waste your time so I will "cut to the chase". I offer my recommendations on the President's current public perception problems regarding his decrease of public and world community support concerning Iraq. "A picture is worth a thousand words" – the President must paint a picture of the real danger and issues at stake using properly constructed messages through media dissemination. The messages and methods currently being used by the administration are not working as well as other possible alternatives. For example, to begin with, possibly a personal interview during prime time with one of the network anchors to re-emphasize again and again the following:

-He must continue to communicate to the world that Saddam Hussein has not explained what happened to the tons of mustard and nerve gas, anthrax, etc. that was manufactured prior to and during the last decade. This should be communicated through vivid examples that will "hit home" such as stating, "The thousands of people that demonstrated against the disarmament could be killed within \_\_minutes or hours with one vile of mustard gas containing \_\_\_ounces being released within the crowd." (I heard on a radio talk show the exact amounts unaccounted for and was appalled by the amounts – tons!)

-He must actually "display" the photos, as gruesome as they may be, of the Kurds that were killed when Saddam Hussein used these biological weapons on his own people – again leaving the image of the actual photos of the atrocities committed in the past embedded in people's minds.

-The President must emphasize, and re-emphasize, repeatedly how quickly an attack can happen again in any country that missiles can reach – especially his neighbors, Muslim or otherwise, as Saddam Hussein has attempted in the past. He must emphasize that "No one is safe" in the current environment.

-He should select a major city in the Middle East and Europe and "demonstrate", through photos, drawings, etc., -"circles of death" - how quickly thousands of people can be killed by just ONE missile containing the weapons we know Saddam Hussein possess and again have yet to be accounted for.

-He has to keep re-emphasizing what could happen if these unaccounted for weapons are sold or made accessible to other potential hostile governments, individuals, or fanatical groups.

-To keep re-emphasizing the real danger if we do not disarm, he should talk about Homeland Security issuing "High, Moderate, Low Terrorist Alerts" now on the six o'clock news as a normal activity as if we are predicting and preparing people for a snow storm.

-He may want to explain the "real" reasons France, Germany, Turkey, etc. are not on board – economic or otherwise – this is war and we will not garner or enlist their support now anyway.

Andy, I regard our President too highly to witness his leadership skills and his Cabinet's tremendous knowledge and experience be questioned or destroyed by not utilizing every possible persuasive communication avenue to explain the real danger to the world. Unfortunately, this has to be treated like a simple advertising campaign – to be implemented immediately. From our success with capturing al Qaeda leadership to repeating the how the World Trade Center tragedy can again happen – these messages have to be repeated and re-emphasized over and over again to sink into the minds of the world community.

As you know, my expertise is crisis management and I have taught evening graduate level courses on this subject at Boston University for nearly ten years, while working in senior communications positions in the corporate sector for 25 years. Under the shield of secrecy, I would be honored and willing to discuss, help, and formulate communications plans with you, your aides, Karen Hughes or any of the rest of the Presidents Communication Staff at mv own expense should you so desire at any time – 24/7. Dear Mr. Card:

As you may know, over the last several weeks numerous news outlets have uncovered evidence that Republican Congressional leaders requested political donations explicitly in exchange for favorable legislative actions. Subsequently, I have requested in writing an investigation by the Department of Justice into these allegations. I have also requested that Attorney General Ashcroft recuse himself from any investigation due to his close ties to the company in question, Westar Energy Inc.

As of this writing, there has been no response to my request that the Justice Department immediately seize all documents and electronic correspondence relating to the pay-for-play allegations from the offices of Representatives Tom DeLay (TX), Rep. Joe Barton (TX), Rep. W.J. "Billy" Tauzin (LA) and Senator Richard Shelby (AL). Because of the serious nature of the allegation, I believe it is vital that the administration do that which Attorney General Ashcroft has yet to do: direct an immediate investigation of the Westar scandal.

Federal law, as I'm sure you are aware, prohibits anyone to promise any public benefit "provided for or made possible in a whole or in part by any act of Congress...as consideration...for any political activity or for the support of...any candidate."

I have attached for your review copies of my letters to Attorney General Ashcroft and documents detailing the quid pro quo between Westar and Representatives Delay, Barton and Tauzin and Senator Shelby. I understand that you are in New Hampshire today. I hope that you can take time out of your busy schedule, perhaps while traveling to or from the Granite State, to contact Attorney General Ashcroft.

With the potential violations of federal law, I hope the Bush Administration agrees that this matter deserves immediate attention.

Last week, en route from Vienna to meetings at the UN in New York, I stopped off in Washington for a few hours. I did so in large part to continue a dialogue with Administration officials regarding various activities in which the IAEA is currently engaged.

Among others, I met with Will Tobey, of the NSC, who had participated in previous meetings that Mohamed ElBaradei and I had with Condoleezza Rice. Will had contacted me last month in response to my letter to you of 22 May concerning the situation resulting from the looting that occurred at the Tuwaitha Nuclear Research Center near Baghdad.

My discussions last week with Will and others included the IAEA's ongoing NPT inspection activities at the Tuwaitha facility, as well as issues related to Iran's nuclear program — which is being considered by the IAEA's Board of Governors this week here in Vienna. It is our intention that this dialogue — which has been helpful in reaching understanding regarding the NPT inspections in Iraq — will contribute to maintaining the best possible understanding of our work by the Administration.

As mentioned in my earlier letter, please do not hesitate to contact me should you or members of your staff have any questions regarding our activities.

### African American Inroads for the GOP

Last year three African Americans running statewide for offices in the same state were all elected, something that had never happened before in any state, even during Reconstruction. The African Americans are Democrats, and the state is one of those proudly, reliably liberal ones -- Massachusetts, perhaps, or California, right?

Wrong. The state is Texas, and all three winners are Republicans. Their successes suggest how Republicans might make modest progress with African American voters. Modest progress -- say, 15 percent rather than 8 percent of the African American vote -- could have large effects.

Two of the Texans, Wallace Jefferson and Dale Wainwright, were elected to the state Supreme Court, which has nine justices. The third is Michael Williams, who in 1998 became the state's first African American to hold a statewide executive position when he was appointed by Gov. George W. Bush to complete the term of a departed member of the Texas Railroad Commission. He was elected to the commission in 2000 and reelected last year.

The commission has precious little to do with railroads. It regulates the state's oil and gas industries. Which is to say, it matters. Williams was here recently on errands both energy-related and political, wearing a big bow tie and a bigger smile, anticipating those modest gains.

Being born in Midland, Tex., was a shrewd career move by Williams, who returned there after attending the University of Southern California and staying there for law school. In 1978, at age 25, he ran for county attorney in Midland and was, he cheerfully says, "slaughtered." Part of the problem may have been his campaign manager, a callow whippersnapper named George W. Bush. Williams, his head then adorned by a lush Afro, persevered.

In 1990 the first President Bush appointed Williams as assistant secretary of education for civil rights, and he soon riled the civil rights lobby by ruling that college scholarships exclusively for minorities are illegal. Today his head is shaved and full of thoughts about how Republicans can make inroads with African American voters. This, he says, is how: slowly, state by state, with statewide candidates. Ken Blackwell agrees.

Blackwell, another Republican, is Ohio's secretary of state and the nation's senior, in length of service, African American holder of a statewide office. He was elected Ohio's treasurer in 1994, when he the first Ohio African American elected to statewide executive office. A conservative who supported Steve Forbes for the 2000 presidential nomination, Blackwell notes that if Al Gore had received the votes Ohioans gave Ralph Nader, Bush would have carried the state by just 1 percentage point instead of 4. So it might be momentous if in 2004 Bush increases his share of Ohio's African American vote from 9 percent to, say, 15 percent.

Winning reelection last year, Blackwell won 50 percent of the African American vote, but he does not think this helped the gubernatorial candidate at the top of the Republican ticket, Bob Taft, who won without significant African American support. However, Blackwell believes that his own statewide

success made it easier for Taft to select an African American, Jennette Bradley, as his running mate for lieutenant governor.

The second African American elected lieutenant governor last year is Michael Steele, the first African American ever elected statewide in Maryland. Steele is a Republican (as was the only African American elected lieutenant governor in 1998 -- Joe Rogers in Colorado). Robert Ehrlich, who selected Steele and is now governor, may have received as much as 14 percent of the African American vote, while his opponent, Kathleen Kennedy Townsend, did not get the African American turnout she needed.

Before the 2000 election, the most prominent African American in public life was Supreme Court Justice Clarence Thomas, who is prominent because of a Republican, the first President Bush. Never have African Americans been as prominent in a presidential administration as they are in the current one, given the war against terrorism and the prominence of Colin Powell and Condoleezza Rice in the waging of it. Before the war eclipsed domestic policy, the president was particularly interested in education policy, which is the purview of Secretary of Education Rod Paige, an African American.

Britain's Conservative Party gave the country a Jewish prime minister, Benjamin Disraeli, and a female prime minister, Margaret Thatcher. The second African American elected governor of an American state since Reconstruction -- Douglas Wilder was the first, in Virginia in 1989 -- may come from America's conservative party, the ranks of whose elected and appointed officials are decreasingly monochrome. And the successes of African American Republicans in statewide elections will begin to produce modest -- and tremendously consequential -- Republican gains among African Americans in presidential elections.

As you may know, the Federal Motor Carrier Safety Administration (FMCSA) released its new, final truck driver hours of service regulation today-an important trucking safety regulation that has been more than 6 years in the making. The purpose of this letter is to communicate the American Trucking Associations' (ATA) strong support of this final rule.

It is clear to ATA that the U.S. Department of Transportation and FMCSA took to heart the tens of thousands of comments received during the year 2000 on their HOS proposal. FMCSA officials did their homework and got it right this time, including conducting a comprehensive benefit-cost analysis performed by an independent firm. ATA believes that the new rules will, first and foremost, promote highway safety. We also believe they will allow the trucking industry to do what we do best-move America's freight safely and efficiently.

The new (and final) rules appear to be based not only on the best available science, but they are also rooted in good, common sense. The rules increase the amount of off-duty rest time each day for drivers by 25%, they reduce the amount of on-duty time each shift, and they promote the body's natural 24 hour circadian clock. Plus, the rules are easy to understand, easy to comply with and, for the enforcement community, we believe they will be easy to enforce. In fact, these are three guiding principles that have underpinned ATA's longstanding position on this important safety issue.

Today my friend LeRoy McMath of Dallas, Texas called.

And this letter is about LeRoy, one of the my dearest friends. It's a friendship that extends fifty years this spring, from our Air Force flight school days. We call each other at least once a week. Today's call was to tell me that he planned to accept hospice rather than continue chemotherapy treatment for cancer.

In the past when writing my Christmas letter would include a paragraph about one special friend, one that meant so much to me. Following is from my 1999 Christmas letter about LeRoy.

Quote

From Longview drove back to Dallas attending Sunday church service with LeRoy McMath and his family. LeRoy is a Brother at the Woodin Boulevard Church of Christ in Dallas and he is my Brother. We were in Air Force flight school together. LeRoy was the only black Aviation Cadet on base in Florida, and also later in Mississippi. Following a distinguished Air Force career as an Officer including B-47 Aircraft Commander he retired after 24 years service. Then at 63, he decided to devote his life to the Lord, and started seminary to become a preacher.

But that is just part of LeRoy's life.

LeRoy was raised by his grandparents in Alabama, and poor.

He joined the Air Force in 1949 and after three years of enlisted, applied and was accepted as an Aviation Cadet for flight training. LeRoy graduated as one of the six honor graduates in our class.

When LeRoy was selected for B-47 Aircraft Commander school he was flying F-86s in England. On arrival for training said he was the only First Lieutenant, and, "Certainly the only black 1st/Lt!"

LeRoy was the first black B-47 Aircraft Commander at Lincoln AFB, maybe in the Air Force, doesn't know. He was on the fast track to Colonel when he started to come down with rheumatoid arthritis and rather than stay in just for promotion elected to retire as Lt/Colonel. He also flew in Vietnam.

Following retirement LeRoy earned an MBA at SMU before entering business.

As mentioned, at 63 he dedicated his life to the Lord and following graduation from theological school entered the ministry.

LeRoy and his lovely wife Lynda, who just retired as a public school teacher, are raising KeShawn Porter, now 15, sending her to a private school.

LeRoy even enrolled with KeShawn in Tae Kwon Do school becoming a black belt in karate. Don't mess with that preacher!

Mr. President, I realize you have the weight of the world on your shoulders but, if possible, would greatly appreciate your sending LeRoy a picture from your Air Force/Guard days for his birthday on February 7 signed "To LeRoy, from one fighter pilot to another." Can't tell you the happiness that will bring him and it will add days, weeks, and maybe a month to his life be assured of that.

When I attended church service with him, he would try to arrange it so he could preach and would always remind the congregation that your Dad and I were friends, and they loved it.

At the start of your campaign was going to suggest you attend a Woodin service but that was the time LeRoy started getting sick. And now LeRoy is unable to attend church but they bring the service to him.

If unable, will understand as would LeRoy. His address is below.

Told LeRoy that first we had to write our joint autobiography, Black and White Cotton Pickers from Alabama and Texas. We laughed!

Will close on a personal note.

I remember I first told you at RDU August 26, 1999 after a lapse of eleven years, "God bless you George." God bless you Mr. President.

I volunteer my services to you, and life to our country if need be.

THE WRIGHT BROTHERS AT FORT MYER, VIRGINIA . . . JULY 30, 1909  $17 \times 24$  INCHES

ON JULY 30, 1909, a Wright flying machine operated by Orville Wright, and carrying Lieut. Benjamin D. Foulois as official observer, successfully performed its final test required for military acceptance. The machine was accepted by the United States Government on August 2, 1909, making it the number one acroplane of the U.S. Military Service.

The painting depicts the spectators and key personnel witnessing the trials originating from the parade grounds at Fort Myer, Virginia, this nation's first site for the flight testing of a Military Aeroplane.

In the center foreground stand Wilbur Wright, holding signal flag, Lieut. Benjamin D. Foulois, Lieut. Frank P. Lahm, and Orville Wright. Leaning against the plane are Charlie Taylor, chief mechanic for the Wright Brothers, and Carl H. Claudy, photographer commissioned by the Signal Corps to supervise the photo coverage of this historical event.

The flying machine is resting on a small truck that ran on a monorail used to catapult the plane into the air. Pull for the catapult was produced by the dropping of a weight from a derrick constructed to the rear of the rail and geared by ropes and pulleys.



EUGENE ELY TAKING OFF FROM THE U.S.S. PENNSYLVANIA ... JANUARY 18, 1911 17  $\times$  24 INCHES

ON JANUARY 18, 1911, Eugene Ely, flying a Curtiss Pusher, took off from the Presidio in San Francisco and flew out to the U.S.S. Pennsylvania at anchor in San Francisco Bay. A landing stage approximately 130 feet long and 32 feet wide had been constructed on the stern of the Pennsylvania. Arresting ropes with sandbags attached to both ends were laid across the landing deck to bring the plane to a halt. The aeroplane's landing gear was fitted with hooks to catch the arresting ropes.

Eugene Ely skilfully landed his aeroplane on the platform of the Pennsylvania. Within the hour, the Curtiss plane was turned about and Ely took off from the warship and flew back to the Presidio. This was the first time that a landing and take off had taken place from the deck of a warship. A few months previously Ely demonstrated the feasibility of taking off from a ship, using the U.S.S. Birmingham for this feat. The ability to land and take off from the Pennsylvania convinced the Navy that the aeroplane had some practical use.

The painting portrays Ely taking off from the U.S.S. Pennsylvania. Sailors climbed to all parts of the superstructure to witness this historical event.

It Takes Two to Wage Peace

#### BY TRUDE B. FELDMAN

ASHINGTON The year was 1960. The nation of Israel was 12 years old. I had come for the first time to the Middle East. As the ship docked at Halfa, I was too werk to fucl excitement. For 13 of 14 days at sca. I had been miserably seasick.

It was an inauspicious beginning to a long relationship with a promising but troubled country. During that first visit, which be-

came a two-year sojourn, I had a bit part in the film "Exodus." attended weekly Bible sessions held by Ismei's first prime minister, David Ben-Gu-rion, and met other leaders and officials from many countries. As a bud-ding journalist, I covered all 122 sessions of the Adolf Elemann trial and interviewed his wife, attorney and most of the witnesses. On assignment for Ebony magazine. I toured the country with sloger Harry Bela-fonte during his two-week angagement, and for another five days with Elennor Roomwelt

Through it all, I marveled at what the modern ploneers had achieved since independence. As the former first lady told me: "Israel is a lesson in how one can develop a nation ... Out of the sands, the people have carved a wonderful builtful existence."

But out of those same sands have also come strife and conflict.

Over the years, I have watched as cach of LSTREFS 11 prime ministers and their foreign ministers have tried include and again to fashion a working incace with their neighbors, including incace with their neighbors, including the Palestinians. I witnessed mo-ments of optimism, as in 1977 when I covered Egyptian President Anwar Sadat's peace mission to Jerusalem to meet with Iarael's sixth prime min-ister, Menachem Begin, And I was addened when the forces opposed to beace seemed to get the upper hand, as when Sadat was assassinated in 1981 by Muslim extremists.

Today, as Israel and the Polestinians stand poised for yet another atcmpt at a comprehensive solution, I reflect on my numerous discussions on the subject with the region's leaders and with their American counterparts. One bit of wisdom stands out. stated a bit differently by each. As Is-raci's fourth prime minister, Golda Mcir, said: "Only those who make war

con make peace." The so-called road map, formu-inted by the U.S., the United Nations, Russia and the European Union, lays out a plan for concrete steps that Is-racils and Palestinians could take in a move toward peace and a Palestinian state. But in the end, it is the two par-lies that must decide to act.

The region's leaders, in principle, have always wanted peace. In 1960, Ben-Gurion told me he was optimis ic about the future, describing the rouble between Ambs and Jews as a family conflict which will not last more quickly we draw together, the velter it will be for both of us."
