# U.S. Justice Department Joins Civil Suit Tied to HealthSouth (WSJ, 5/29/02)

The Justice Department joined a civil lawsuit against <u>HealthSouth</u> Corp., alleging the company defrauded Medicare and other government programs in part by submitting false claims for physical-therapy services by "unqualified personnel" at its outpatient clinics.

The company, based in Birmingham, Ala., said it would defend itself "vigorously" against the accusations.

The government's complaint, filed May 23 in U.S. District Court in San Antonio, intervenes in a civil suit filed against the company by a HealthSouth patient under the False Claims Act, which essentially allows individuals to file suit on behalf of the government. The complaint alleges in part that from April 1992 to the present, HealthSouth improperly billed the government for physical-therapy services provided by "unqualified personnel."

The complaint also alleges the company sought reimbursement for patients treated without properly certified care plans.

According to the complaint, HealthSouth "systematically" uses supportive personnel, such as aides or trainees, to treat Medicare beneficiaries, but bills Medicare as though licensed therapists or assistants provided the care.

A spokesman for the company called the action a "nuisance suit" and said its lawyers have advised HealthSouth that it has done nothing wrong and need not change the way it does business.

In a Securities and Exchange Commission filing, HealthSouth said its practices are "consistent with accepted clinical standards and practices in physical therapy" and with current Medicare regulations.

A HealthSouth spokesman said the use of aides, or "extenders," is common and necessary to provide "concurrent" therapy, in which several patients with different ailments perform individualized therapy at the same time. The "extenders" assist patients under supervision of a

licensed therapist, who is typically within eyesight of the aides, the spokesman said.

The complaint seeks unspecified damages and civil penalties.

HealthSouth is the nation's largest provider of outpatient physical-therapy services. But Medicare outpatient reimbursements represent roughly 1% of its total revenue, its spokesman said.

Analysts have said the suits don't appear to pose serious financial concerns for HealthSouth. "I don't think it's something that investors are overly concerned with," said Joel Ray, an analyst with Wachovia Securities.

The Justice Department earlier this year had said it would intervene in another, similar suit filed against HealthSouth in Alabama. But the department withdrew its intervention in that case earlier this month, HealthSouth said.

HealthSouth runs rehabilitation hospitals and outpatient rehabilitation, surgical and diagnostic clinics.

In New York Stock Exchange composite trading at 4 p.m. Tuesday, shares of HealthSouth were down two cents at \$14.08.

when a crumbling economy, a decaying Cold War security structure, and an ethnic-Albanian insurrection against the Serbs in Kosovo combined to intensify ethnic strife and create conditions favorable to greater violence.

*Conditions favorable* does not signify inevitability, only a strong possibility if policymakers ignore the evidence. Yugoslavia was not so intractable or complex that Margaret Thatcher could not have stopped the war from spreading into Bosnia with the angry rap of her handbag at any of several NATO meetings in 1991 or early 1992, had she still been the British prime minister.

Since early warning is a sine qua non of crisis prevention, and because individual circumstances such as the Conservative party coup that toppled Thatcher from power in 1990 cannot be foreseen, foreign policy must be the art of intelligently organizing what information can be foreseen, so as to provide a framework, albeit indistinct, for future events—that is the lesson of Machiavelli's "anxious foresight."

What can be foreseen is what changes slowly or not at all: climate, the resource base, the pace of urbanization, interethnic relations, the strength of the middle class, and so on. One reason the United Nations keeps track of literacy and fertility rates (and then ranks countries in a "Human Development Index" according to such factors) is that they are descriptive of the present and instructive of the future.

The canceled second round of Algerian elections in January 1992 was not the cause of Algeria's Islamic terrorism and civil conflict but merely its "beginning." The causes include the astoundingly high rates of population increase and urbanization for decades prior to 1992, so hordes of frustrated, unemployed young males overwhelmed the cities and shantytowns.<sup>2</sup> There was also the reinvention of Islam in a modern and impersonal urban setting, giving it an ideological severity it lacked in the villages. These circumstances could easily have alerted policymakers to Algeria's increasing tendency for conflict.

In 1989, when the Berlin Wall fell, an analyst relying solely on the evidence of history, culture, and geography could have anticipated the condition of former Warsaw Pact countries a decade later. Before World War II and the Red Army flattened Eastern Europe, the Protestant-Catholic lands of eastern Germany, Poland, Hungary, and western Czechoslovakia-all once part of the advanced Habsburg empire-had boasted large and vibrant middle classes. Industrial production in western Czechoslovakia rivaled that of England and Belgium. Not so in the Eastern Orthodox Balkan nations and Russia, burdened by centuries of Byzantine, Ottoman, and czarist absolutism, where middle classes were tiny specks amid vast peasant populations. Of those poorer nations, Russia was always the worst off, its social fabric rent by more decades of communism than the Balkans, and its problems further complicated by sheer size, ethnic diversity, and proximity to the least stable parts of Asia. Not surprisingly, by 2000, the order of economic development in Eastern Europe was roughly what it had been prior to World War II, with the northern, ex-Habsburg part of the region the most prosperous, the Balkans further behind, and Russia in the worst condition. Croatia, meanwhile, befitting the destiny of a marchland between Central Europe and the Balkans, was torn by Balkan violence in the 1990s, but is now moving toward civil society faster than its southern neighbors.

There are exceptions to this historical and cultural pattern: Serbs,

who are worse off than many urban Russians; ethnic-Hungarian Catholics in northern Serbia, who are worse off than Orthodox Romanians in Bucharest; and, most dramatically, Greece—an Eastern Orthodox, Balkan nation that ranks ahead of Poland, the Czech Republic, and Hungary on the United Nations Human Development Index.<sup>3</sup> But Greece's escape from communism and Balkan underdevelopment required an American-backed counterinsurgency against communist guerrillas, followed by \$10 billion in Truman Doctrine aid (in 1940s dollars) for a country of only 7.5 million people, and gross interference by the Central Intelligence Agency in Greece's domestic politics through the 1950s.

The benefits of using historical and cultural models to glimpse the future are obvious, but so are the drawbacks. What if the Truman administration had abandoned Greece? In the late 1940s, Eastern Orthodox Greece was economically backward, without a traditional middle class, torn by civil strife, unexposed to the Western Enlightenment, and geographically and spiritually closer to Russia than to the West. History and geography clearly suggested that helping Greece was a lost cause. Yet, it succeeded. And as expensive as U.S. intervention in Greece turned out to be, it was cheap compared to the cost in American defense outlays and human suffering had Greece become a Soviet satellite in 1949.

The collapse of the Soviet Union is another argument against what Isaiah Berlin dismissed as "historical inevitability."<sup>4</sup> No matter how infirm the Soviet system was, the spectacle of a continental empire crumbling quickly on its own, with no invading army to instigate it, had few precedents in history. It was this dramatic, unforeseen conclusion to the Cold War that led one of Berlin's colleagues to declare: " 'Inevitability' has rather a bad track record."<sup>5</sup> A stirring argument against inevitability is the *Shi ji*, or *Records*  of the Grand Historian, by Sima Qian, the Thucydides of ancient China, whose history of the Qin and Han dynasties includes many passages like this:

Chen She, born in a humble hut with tiny windows and a wattle door, a day labourer in the fields and a garrison conscript, whose abilities could not match even the average . . . led a band of several hundred poor, weary soldiers in a revolt against Qin. . . . The weapons which he improvised from hoes and tree branches could not match the sharpness of spears and battle pikes; his little band of garrison conscripts was nothing beside the armies of the Nine States. . . . Qin [was] a great kingdom and for 100 years made the ancient eight provinces pay homage at its court. Yet, after it had become master of the six directions . . . a single commoner [Chen She] opposed it and its seven ancestral temples toppled. . . .<sup>6</sup>

If the future were really discernible, political science would enjoy more respect than it does, and determinism—the belief that historical, cultural, economic, and other antecedent forces *determine* the future of both individuals and nations—would not be such a disreputable word. Wars have seldom been won by fatalism, and battlefield victories against great odds have regularly changed the direction of history. "One of the perennial infirmities of human beings," writes the late British historian Arnold Toynbee, "is to ascribe their own failure to forces that are entirely beyond their control."<sup>7</sup> A great leader needs some sense of idealism and possibility. Machiavelli's *Prince* has endured partly because it is an instructional guide for those who do not accept fate and require the utmost cunning to vanquish more powerful forces.

Yet, it hardly follows that policymakers should ignore all factors, objective and subjective, that forewarn them of crises, and which may prevent them.

Determinism has been argued about since the Greek Stoics identified two seemingly contradictory notions: individual moral responsibility and "causation"—the belief that our acts are the unavoidable result of a chain of prior events.<sup>8</sup> It was the determinism of the medieval Catholic Church, which believed that history had a single direction and purpose, that Machiavelli revolted against. Twentieth-century history makes determinism the pithiest philosophical issue facing policymakers today, for behind the errors of Marxism and other follies lay the error of reading from the past too narrowly into the future.

While Marxism is the classic case of a determinist philosophy, determinism was also a factor in the appeasement of Nazi Germany in the 1930s. Appeasement revealed the danger of a narrow fixation on power—who has it and who doesn't—which puts one in the awkward position of seizing it oneself or knuckling under. To wit, the pro-appeasement editor of *The Times* of London, Geoffrey Dawson, asked, "If the Germans are as powerful as" people say, "oughtn't we to go with them?"<sup>9</sup> Chamberlain believed Hitler's rearmament was a troubling but inevitable outcome of Germany's industrial capacity, its large and dynamic population, and its strategic position at the heart of Europe. Thus, the Nazi leader could not be stopped.

Unlike the respectable and upright Chamberlain, Churchill was a drinker and surrounded himself with a "disreputable crowd of roués.<sup>210</sup> It was precisely such a personality, unstable and overbearing, that was an antidote to Chamberlain's fatalism. Churchill's exuberance and sentimentality regarding the British empire made it impossible for him to imagine an outcome that the British prime minister did not help shape. Thus, he grasped the illogic of Chamberlain's attitude toward Hitler, which nullified the influence of Chamberlain himself.

Churchill was by nature a pluralist: someone who believes that many things (particularly his own actions) interact, and that no one thing *determines* the future. Like Ronald Reagan, another leader who proved more clairvoyant than the foreign affairs mandarinate that disdained him, Churchill was blessed with a moral passion—a "clean hatred"—that proved more effective than Chamberlain's pragmatism and fatalism.<sup>11</sup> Reagan's first inaugural address might have been lifted from Churchill: "I do not believe in a fate that will fall on us no matter what we do. I do believe in a fate that will fall on us if we do nothing."

It may have seemed irrational for Reagan to believe in the 1980s that the Cold War was temporary and that the Berlin Wall would collapse. Reagan thereby exposed another characteristic of determinism: that of being overly rational, a flaw to which policy analysts and other experts are especially prone. A merely rational man might not have challenged Hitler the way Churchill did.

Whereas Churchill and Reagan represented strategic and moral decisiveness against considerable odds, in 1993 President Clinton appeared to represent the fatalism of the appeasers by failing to intervene in the former Yugoslavia to stop war crimes committed by Bosnian Serbs against Bosnian Moslems.

Some of the strongest criticism against Clinton's failure to inter-





Dear Mr. President:

We write to urge that you give full force and effect to the important human rights provision commonly known as the Kemp-Kasten amendment, which governs the eligibility of international organizations for U.S. foreign assistance funds.

The Kemp-Kasten provision prohibits the obligation of any U.S. funds to "any organization or program which, as determined by the President of the United States, supports or participates in the management of a program of coercive abortion or involuntary sterilization." Because of the abundant evidence of forced abortion and forced sterilization in the population control program of the People's Republic of China, and because the United Nations Population Fund (UNFPA) has long been among the principal international supporters of this program, we believe the law clearly prohibits a United States contribution to UNFPA.

Between 1985 and 1992, an unbroken series of determinations by Presidents Ronald Reagan and George H. W. Bush concluded that the Kemp-Kasten amendment prohibited U.S. funding to the UNFPA. This outcome was required not only by the letter and spirit of the Kemp-Kasten law, but also by respect for the rights of women. President George H.W. Bush even vetoed the 1989 Foreign Operations Appropriations bill because it would have required a U.S. contribution to UNFPA.

The Reagan and Bush Administrations' compliance with the Kemp-Kasten amendment was supported by the U.S. Court of Appeals for the District of Columbia. In a decision written by Judge Abner Mikva, the panel unanimously ruled that the AID administrator's swom explanation "of how the UNFPA's activities in China aid the aspects of China's program that Congress condemned amply supports his conclusion that funding UNFPA is prohibited by the [Kemp/Kasten] amendment." [Population Institute v. McPherson, Civil Action No. 85-6042, decided August 12, 1986, p. 23].

In 1993, the Clinton Administration dramatically revised the official interpretation of the Kemp-Kasten amendment in order to facilitate U.S. funding of UNFPA. That Administration required proof that an organization "knowingly and intentionally assist in perpetrating the human rights abuses that are identified in the statute by providing funds or technical management assistance directly to coercive abortion or involuntary sterilization" (1993 AID legal analysis of

Kemp-Kasten amendment). The new requirements that support for coercive practices be "knowing," "intentional," and "direct" are entirely absent from the text and legislative history of the statute. They virtually guaranteed funding for the UNFPA, especially in light of the difficulties of proof in a country such as China, where government programs operate behind veils of secrecy and people who complain about coercion are likely to face retribution at the hands of the state.

Even under the Clinton Administration's view of the law, its conclusion that UNFPA was eligible for a U.S. contribution depended on uncritical acceptance of UNFPA's own self-serving version of the facts. Evidence received at a recent Congressional hearing indicates that there is still widespread coercion in one of 32 "model" Chinese counties in which UNFPA works closely with Chinese family planning authorities, and in which UNFPA has undertaken to monitor the government's compliance with its promise to eliminate birth quotas and other coercive practices.

On October 17, 2001, the House International Relations Committee heard testimony from an independent, undercover investigative team that was sent to Sihui county. Sihui is one of the 32 counties in China where the UNFPA operates and claims that abortion and sterilization are strictly voluntary. The UNFPA scaled back to 32 counties in 1998 to counter criticism of its continued support and defense of the coercive Chinese program. The investigators in Sihui county recorded testimony from many victims and witnesses of coerced abortion and involuntary sterilizations, and the stories told by Chinese women were heartbreaking. As interviews were being conducted and recorded, bystanders often gathered and began to tell their own stories of being forced to have an abortion or sterilization.

Women told the investigators that family planning is not voluntary in Sihui. They testified that coercive family planning policies in Sihui include: age requirements for pregnancy; birth permits; mandatory use of IUDs; mandatory sterilization; crippling fines for non-ompliance; imprisonment for non-compliance; destruction of homes and property for non-compliance; forced abortion and forced sterilization.

At a January 24, 2002 press conference, Mrs. Gao Xiao Duan, who served for 14 years as a planned birth officer in the Fujian province of China, released a statement that said, "I do know that any organization that is contributing to China's population control policy is encouraging these officials to implement forced abortion, sterilization and punishments ranging from detainment to house destruction as means of enforcement."

Thousands of women from all parts of China have gained asylum in the United States because they were victims of coerced abortions or involuntary sterilizations. These asylum cases have not abated because the coercive program in China continues to victimize women and children. The UNFPA's monetary support of the Chinese program alone makes it ineligible for U.S. funding. UNFPA 's continued public defense of the coercive Chinese population control program, while it abuses women in the very counties in which UNFPA operates as its partner and ostensible monitor, constitutes yet another form of support.

Time and again, high officials of the UNFPA have defended the indefensible and assured

the world that the PRC program is purely voluntary. In January of this year Nafis Sadik, who served as Executive Director of UNFPA from 1987 until 2000, accepted the Population Prize Award from the Chinese government. In her acceptance speech Sadik said:

"I have had the honor of being associated with China's reproductive health and family planning programme for more than two decades. I was instrumental in initiating UNFPA's cooperation with China in 1979. Since then, and especially after becoming UNFPA Executive Director in 1987, I have visited China many times. On each visit I discovered that many changes had taken place in almost every aspect of life in this great country. I was most impressed with the strong political will of the Chinese leaders at different levels, and the great enthusiasm and seriousness the Chinese people, including the reproductive health and family planning workers. Looking back, I feel a great sense of pride for the Chinese Government and people for their support to UNFPA and to me, personally, I also feel proud that UNFPA made the wise decision to resist external pressures and continued its fruitful cooperation with China."

Sven Burmester, UNFPA's representative in Beijing, also praised China's program when he said, "In strictly quantitative terms, it was the most successful family-planning policy ever developed."

The United Nations' stamp of approval is critical to the continued success of the coercive Chinese program. So long as the UNFPA, with U.S. funding, describes the Chinese program as "successful" and insists that forced abortion and forced sterilization in the program are limited to "isolated abuses" by "overzealous local officials," the government will be free to continue its systematic abuse of women and children.

We urge you to enforce the law by denying funding for UNFPA. Indeed, even if the law and the facts were less clear the decision whether to fund UNFPA would be purely discretionary, and we would urge that you use your discretion to withhold funding. Surely the United States can find some use for \$34 million that will promote, rather than endanger, the welfare and the fundamental rights of women and children.

Dear Mr. President:

Mayor Anthony Williams and I request a meeting with you to discuss the importance of bringing major league baseball back to the Nation's Capital and to seek your subtle but crucial support.

As you know, the baseball landscape is changing rapidly. Commissioner Bud Selig has called an emergency meeting this Tuesday to update the owners on the status of eliminating two franchises for next season. Since Selig's original announcement three weeks ago, several legal hurdles have arisen that have put his plan in doubt. Despite this, it appears MLB seems determined to move forward with contraction.

We believe relocating a team to the Washington area provides Major League Baseball with a positive alternative to contraction. Whether in D.C. or Northern Virginia, this would be an important step in revitalizing the area and restoring some of the damaged spirit of September 11<sup>th</sup>. Furthermore, we have a great market that would make sound economic sense for MLB.

For nearly three years, our group has worked with the City to demonstrate a true public/private partnership in this pursuit. Together, we have identified several attractive locations for a new hallpark, agreed on various revenue streams to help linance a new stadium, and commissioned studies clearly establishing the viability of a Washington D.C. franchise.

Our group, The Washington Baseball Club, consists of six individuals with long and deep ties to the District including Jim Kimsey, Founding Chairman of America Online, Frank Raines, Chairman and CEO of Fannie Mae, and Joe Robert, Chairman of JER (the largest real estate investor in the area). We are committed to consistently fielding a competitive team.

However, we are not motivated simply by a desire to own a baseball team. In light of recent events, we believe, now more than ever, bringing baseball to Washington would help revitalize the city's economic scene, re-energize its tourist business and reaffirm its place in the world. As a former MLB owner and current resident of Washington, D.C., you, better than anyone, could make the case that returning baseball to the City is important to the economic landscape of this region and integral to the future success of Major League Baseball. Also, as President, your views would underline the symbolic importance of this lift for the Nation's Capital at this point in our history.

We hope you share our sentiment. We look forward to discussing the return of baseball to the Nation's Capital with you in more detail and hope you might make a call to Bud Selig generally endorsing the idea.

# No Trust, No Progress

WO YEARS ago, U.S. District Judge Royce Lamberth gave the government one last chance to begin setting straight the long-abused system under which money is held in trust accounts for hundreds of thousands of Native Americans. The order came in a class action lawsuit filed by beneficiaries of these accounts. The trusts, as the D.C. Circuit Court of Appeals later put it, "were created over one hundred years ago through an act of Congress, and have been mismanaged nearly as long." The mismanagement has been so bad that the Interior Department no longer knows who has accounts or how much they should be worth. This would be intolerably bad government under any circumstances, but it is particularly infuriating because the money is not the government's to squander. It belongs to individual Indians, as the proceeds of land that was taken from thêm but was supposed to be exploited (by oil exploration, for example) for their benefit. The plaintiffs have been seeking not damages but an accounting and a restoration of the system.

Convinced that the government was finally serjous about trust reform and had a credible plan, Judge Lamberth decided in 1999 not to put the system into receivership but to monitor the government's reform efforts. During the past six months, two officials appointed by the judge to watch over trust reform have issued a slew of reports suggesting that abuse of the trusts goes on and that reform is something of a myth. Among the conclusions: The

new computer system that was supposed to be the centerpiece of Interior's efforts to fix the system is riddled with problems and may never work; computer security is so lax that hackers can attack data relatively easily over the Internet; the department never got off the ground with a historical accounting of the trust; the efforts to clean up historical data are, as the court's monitor put it, "in disarray"; and, to top it off, the court itself was misinformed about how badly things were going in all these areas.

Judge Lamberth, known for being tough on government lawyers, has responded with characteristic zeal and—as he did earlier in the litigation—has been holding high-profile contempt hearings. But when all of the tablepounding is done, the problem of how to fix the trusts will remain.

The executive branch has shown itself not up to the task. Successive administrations have promised much and delivered little, and there is little reason for confidence in Interior Secretary Gale Norton's latest plan. As ugly as the prospect of a judge supervising a federal agency is, a receiver may not be avoidable at this point. But the litigation can do only so much. Even if as accurate a historical accounting as possible is performed, the records are such a shambles that it won't be good enough. Eventually the White House and Congress will have to intervene and broker a political settlement. At the rate trust reform is going, serious top-level federal involvement cannot come too soon.

This new program is consistent with the recommendations of a report on election reform issued by a national commission headed by former Presidents Ford and Carter.

D. Health

- Global Fund to Fight HIV/AIDS, Tuberculosis and Malaria. The FY 2003 Budget continues the President's \$200 million U.S. commitment to fund a mulitlateral fund to provide prevention, treatment and care activities for individuals affected by HIV/AIDS, TB and Malaria
- Drug Treatment Initiative: The Budget will propose an additional \$168 million as part of the President's Drug Treatment Initiative to support over 50,000 additional drug abuse treatment slots and help narrow the gap between the number of people in need of drug treatment and the number who receive it
- National Health Service Corps (NHSC) and Nursing Education Loan Repayment (NELR). The Budget increases funding for the NHSC and its sister program, the NELR Program, so that health care providers will be placed in the neediest underserved areas.

E. HUD- HOPWA: Increases HUD's Housing Opportunities for Persons with AIDS program, which provides housing and services to persons living with HIV or AIDS, by \$15 million, to \$292 million, and allows more communities to become eligible for formula funding.

F. Labor-- Job Training Programs: The 2003 Budget proposes \$1.5 billion for Job Corps, a residential vocational training program for disadvantaged youth. Although Job Corps is DOL's costliest program, with a unit cost of roughly \$29,000 per service year, research has demonstrated that it is a cost-effective federal investment. The 03 Budget provides a 5% increase above 2002 and would support 122 residential training centers, an increase of four centers.

G. Human Resources - Compassion/Faith-Based Initiatives: The budget continues the Administration's Faith-Based efforts by providing \$100 million for the Compassion Capital Fund, \$20 million for Maternity Group Homes, \$15 million for Mentoring Children of Prisoners, and \$20 million for a Responsible Fatherhood Initiative.

## U.S. Treasury bonds fall 2 points, profits booked

NEW YORK, Dec 7 (Reuters) - U.S. Treasury 30-year bonds extended losses to more than two points on Friday as dealers booked profits before year end and liquidated positions after a massive rally in fixed-income securities this year.

The sell-off extended brutal losses from earlier in the week as dealers have tried to cut back on risk exposure heading into the year end. The size of the losses has been exaggerated by the low level of liquidity in the market, traders said.

"The sentiment in the market is a lot of people are long and made money and now they want to protect their positions and they do that by selling," said Kevin Logan, senior market economist at Dresdner Kleinwort Wasserstein.

Treasuries had earlier surged higher after a report showed a jump in the jobless rate to a six-year high, raising expectations for future Federal Reserve rate cuts.

At 11:10 a.m. EST (1610 GMT), two-year notes were down 3/32 to 99-17/32, yielding 3.24 percent. Five-year notes were down 16/32 to 95-21/32, yielding 4.48 percent. Ten-year notes were down 1-5/32 to 98-23/32, after having earlier gained more than a half point, yielding 5.17 percent -- the highest since early August, while 30-year bonds were down 2-12/32 at 96-12/32, yielding 5.63 percent.

WASHINGTON (AP) - The U.S. Capitol will be open for guided tours on Saturday, Eleanor Holmes Norton, the city's House delegate, announced Friday.


The tours were suspended in October after anthrax-tainted mail was sent to Senate Majority Leader Tom Daschle. Capitol Police said the incidents were unrelated and that the tours were halted so a new screening process for visitors could be designed.

The new security measures require visitors to walk through a metal detector in a facility outside the Capitol. All personal belongings will be X-rayed, and a variety of items - including backpacks, cans, bottles, knives, mace and pepper spray - are prohibited.

The tours were scheduled to resume Wednesday, but were delayed because of security concerns. Lt. Dan Nichols, spokesman for the Capitol Police, said a terrorist alert the government issued Monday was a factor in that decision.

The alert - the third since the Sept. 11 attacks - urged Americans to be extra vigilant during the holiday season because of an increase in credible threats.

Tours will be available from 10 a.m. to 2 p.m. Saturday and every day except Sunday, Norton said.

# Lawsuit Seeks to Block Energy Plan

WASHINGTON (AP) - Environmentalists have sued the Bush administration in an effort to block the president's efforts to accelerate energy exploration on federal land.

The lawsuit claims the Bureau of Land Management and its parent agency, the Interior Department, broke the law by not assessing the environmental and cultural damage that could be done or consulting with Indian tribes before opening a dozen parcels in southern Utah to oil and gas exploration.

The environmental groups that filed the lawsuit Thursday in U.S. District Court in Washington said the administration was trying to cut corners to speed up processing of oil and gas leases. In doing so, the Bush administration has "embarked on an aggressive stealth campaign to open up public lands for resource development," said Johanna Wald, attorney with the Natural Resources Defense Council, which filed the lawsuit in conjunction with the Southern Utah Wilderness Alliance.

"We filed this lawsuit to protect those lands and to stop BLM before it gets started," she said. Recent BLM directives say the agency should "look for opportunities to improve and streamline the management of the (National Environmental Protection Act) process for all energy resource proposals."

The 12 leases cover about 10,500 acres in four parts of southern Utah - the Lockhart Basin south of Moab, the Comb Ridge and Butler Wash area, Montezuma County in the southeastern corner of the state, and two leases in the Mussentuchit Badlands near Capitol Reef National Park. SUWA attorney Steve Bloch said the lands are homes to fragile species of plants and animals, delicate soils, historic Indian ruins and artifacts and spectacular scenery, all of which could be irreparably harmed if oil or gas development is permitted on the land.

SUWA has asked Congress to include 2,400 acres of the disputed land in wilderness areas. Development on the land would prohibit a wilderness designation.

The environmental groups are asking a judge to revoke the leases and require BLM to conduct the necessary environmental and historic analyses.

Wald said a victory in the case would force the administration to conduct the studies whenever it issues oil and gas leases.

BLM spokeswoman Celia Boddington said the bureau does not comment on pending litigation. Four of the 12 parcels at issue were bought at the Sept. 6-7 auction by Lowe Partners of Midland, Texas. Two others were bought by Yates Petroleum Corp. from Artesia, N.M. Six others were bought by agents either buying the land for themselves or unidentified companies.
