Dear Karl,

I'm looking forward to our meeting next Monday in Washington, and want you to know how much I appreciate the time you are sharing with us. The purpose of this meeting is to tell you about IDT's two-pronged outreach program to the Hispanic community.

IDT is starting a non-profit organization which will use IDT's database information for outreach to members of the Hispanic community who buy our calling cards. They will be invited to join a Hispanic-American membership organization called *Logra* (which means Achieve! in Spanish.) The mission of *Logra*, or Latinos for Opportunity and Growth in America, is to provide a voice for this community in preserving the principles of our free society, and to advance a public policy agenda consistent with these principles. This agenda includes promotion of school choice, market based, choice driven health care alternatives, and individually owned retirement accounts to displace social security. As the largest marketer of prepaid phone cards to the Latino community, IDT can make its phone card platform available to Logra for its initial member acquisition campaign.

The second aspect of our outreach efforts is the purchase of WMET (1150 AM) which is IDT's first owned and operated radio station. We have a construction permit to increase the power of this station to 50,000 watts. This will allow us daytime programming to the entire Washington market. Our plan for WMET is to provide balanced, intelligent, informative, articulate and entertaining programming. We already have agreements in place with Linda Chavez, William Kristol, and Charles Krauthammer, and anticipate that this new programming format will begin in the spring of 2003.

Current studies indicate that the Republican party is losing the Hispanic voter by a margin of 2 to 1. We believe that this trend can and should be reversed, and that the initiatives described above can contribute to this effort.

Joining me in Monday's meeting will be Howard Jonas, our founder and Chairman, Ed Miller, Jerrold Rappaport, Mike Benson, and Rabbi Shmuel Boteach. I believe you will enjoy meeting all of them.

Karl, I deeply appreciate your making time for this meeting, and look forward to seeing you next

Monday.

I read with great interest the Wall Street Journal article of November 20, 2002, "Bush Team Considers Proposal to Boast SUV Fuel Efficiency," in which it is proposed that CAFE standards be increased by one and one half miles per gallon from 2005 to 2007.

I am writing to you today to respectively urge you to reconsider this proposal. In my opinion, this may not be the best way to solve the energy problems our country faces. As you have articulated, the U.S. needs to increase energy production, which would help the economy. Raising CAFE standards, in contrast, would place a burden on the American

Let me elaborate. When September 11, 2001, occurred we were already facing an economic downturn. The stock market fell. American industry and the American people faced uncertainty. Fortunately, with you as President of the United States we had the necessary leadership. We also had some leadership from the business community. General Motors Corporation, with Ford and Chrysler following suit, came out with zero percent financing for their vehicles. This was a stroke of genius from the automotive sector because it resulted in motivating the American public to go out and buy cars. The automotive sector is already predicting slower sales in 2003. Increased CAFE standards would make the situation worse for the auto sector because it would force the manufacturers to reduce sales of highly popular SUVS, which provide most of the current profit of automakers.

As you make plans to protect America both here and abroad, the American people are with you. They like and appreciate your leadership. Out in the heartland of America they sing your praises. But the American heartland will be hurt if the proposed new rule on CAFE goes into effect because it will eliminate jobs in states such as Michigan, Ohio, Pennsylvania and Wisconsin where SUVS are made.

If the proposed new rule is fully implemented, it will still not be enough for the radical environmental movement. They will attack you. But it will make it more difficult for the economy to recover, it will hurt vehicle sales and it could produce layoffs. It will ultimately hurt families. The American family wants SUVS because these vehicles can accommodate large families. They provide safety and security for single moms in these tense and difficult times. The American people want to feel secure in their vehicles in an insecure world.

I have always considered families to be the foundation of our country. Let us not create additional difficulties for families and for people who are trying to move us forward economically with this proposed rule. I urge you not to take this course of action. Instead, I hope you will issue a renewed call for Congress to do the right thing and let us produce more energy. This is the only way I believe we will effectively meet the

We would like to follow up on the earlier e-mail inviting the President to participate in a nationally televised town meeting on international issues that will be hosted by University of Texas Center for Deliberative Polling working with MacNeil/Lehrer Productions. This Sunday morning, January 12th event will be held in at the Annenberg Center in Philadelphia and will be a virtually virtually unique gathering of citizens from around the nation. Jim Lehrer will be the anchor. This broadcast will be the highly visible culmination of the weekend's Deliberative Opinion Poll that UT Professor Jim Fishkin is overseeing. What makes this town meeting very much out-of-the-ordinary is the fact the audience participants as a group will be an accurate reflection of the American people. They will come to Philadelphia from around the nation, each recruited in a process built around a rigorous set of academic protocols. And, as in the 1996 Deliberative Poll in Austin at UT, the 350 to 400 citizens attending this town meeting live in more than 200 different locations around the nation and, once gathered together, will be a statistically accurate demographic, geographic, economic and educational microcosm of the nation.

These are uniquely special times for the nation. We think the Deliberative Poll provides the President and the administration with a strong communications opportunity to talk with citizens about the values and long term goals underlying policy decisions, not just the more superficial focus of most television coverage. The nature and the immediacy of the challenges facing "America in the World" make this an extremely timely event that provides a unique communications vehicle. The one-on-one conversation of the Philadelphia town meeting makes possible significant connections, always useful and increasingly important as potential conflict nears. Again, as in the 1996 Austin National Issues Convention, where then Governor Bush welcomed the delegates to Texas, this national project has deep local roots -- many of the participants likely to the subjects of local print and broadcast news coverage. Along with its communications and educational components, the Deliberative Opinion Poll, which surveys participants at the beginning and then the end of the process, provides a textured picture of the views of informed citizens.

The Philadelphia town meeting is the first event in a year long local/national television and community project called By the People. Organized by MacNeil/Lehrer Productions, the project's sole purpose is to help broaden the national conversation about foreign affairs issues. Guided by the NewsHour's standards of objectivity and fairness, the project endorses no positions, points-of-view or policy, but rather works to further the national conversation. Other events through the year will include local public broadcasting station programs and community activities organized by partner organizations which so far include the General Federation of Women's Clubs, the Kiwanis Clubs, the National Black Chamber of Commerce, the American Library Association, the 4H Clubs, the National Issues Forums along with the League of Women's Voters and the 90 local World Affairs Councils. Funding for the By the People project comes from the Hewlett Foundation with the broadcasts supported by the Corporation for Public Broadcasting and PBS.

In our view, the perfect event would be for the President to join the citizen-participants in Philadelphia on Sunday morning, January 12th for an extended conversation that would last slightly less than an hour, covered live. While there are decided benefits of a face-to-face conversation, we would, if you thought more convenient, be able to arrange his participation through an interconnection. We very much hope you find this unusual invitation worthy of Presidential consideration because of the extraordinary opportunity it provides for informal conversation with the American people, assembled in Philadelphia in a highly usual local/national event at a critical time in the administration's and the nation's history.

We understand that the President's intensely busy schedule might make his participation in this event very hard to schedule. That said, and while, of course we very much hope the President could join us, it is critically important that the Philadelphia event provide the administration with a substantive opportunity to talk with the citizen delegates in Philadelphia. Therefore, if this cannot be fit into the President's schedule, we would very much appreciate your support and assistance in our efforts to secure the participation of Vice President Cheney, Secretary of State Powell or National Security Adviser Rice.

Dear Mr. Speaker:

I write on behalf of the Domestic Policy Committee of the United States Conference of Catholic Bishops to express our concern for the workers and their families who will lose federal benefits when the current federal unemployment compensation program expires on December 28, 2002. Just three days after we celebrate the birth of Jesus Christ, we should not allow fellow Americans to be left without hope and support. "If a brother or sister has nothing to wear and has no food for the day, and one of you says to them, 'Go in peace, keep warm, and eat well,' but you do not give them the necessities of the body, what good is it?" (James 2:15-16)

I ask you as Speaker of the House of Representatives to act now and take up this urgent matter. With the Senate already adjourned, you and your colleagues are the only ones who can prevent this from happening. Unless the House--which meets as the 107th Congress for the last time tomorrow, November 22--concurs with the Senate bill and extends the program, no worker can be assured they will be eligible for even a single week of extended benefits in the new year. Indeed, workers who just began receiving their extra weeks of benefits will be cut off completely.

As pastors, we know the human cost of joblessness and the social consequences of inadequate benefits. Pope John Paul II points out that society and the state must protect the worker "either through economic policies aimed at ensuring balanced growth and full employment or through unemployment insurance..." Obviously new jobs are the best answer for those without work, but, in the meantime, we owe these workers some measure of compassion and justice by extending the federal benefits in the unemployment insurance system.

We believe that coming to the aid of unemployed workers and their families is not only good for the economy; it is the right thing to do. Please act now to avoid the tragic consequences of hundreds of thousands of workers without the vital means of support.

Dear Mr. President:

I write on bchalf of the United States Conference of Catholic Bishops to express our concern for the workers and their families who will lose federal benefits when the current federal unemployment compensation program expires on December 28, 2002. Just three days after we celebrate the birth of Jesus Christ, we should not allow fellow Americans to be left without hope and support. "If a brother or sister has nothing to wear and has no food for the day, and one of you says to them, "Go in peace, keep warm, and cat well," but you do not give them the necessities of the body, what good is it?" (James 2:15-16)

I ask you to act now and urge the House of Representatives to take up this urgent matter. With the Senate already adjourned, they are the only ones who can prevent this from happening. Unless the House--which meets as the 107th Congress for the last time tomorrow, November 22--Unless with the Senate bill and extends the program, no worker can be assured they will be eligible for even a single week of extended benefits in the new year. Indeed, workers who just began receiving their extra weeks of benefits will be cut off completely.

As pastors, we know the human cost of joblessness and the social consequences of inadequate benefits. Pope John Paul II points out that society and the state must protect the worker "either through economic policies aimed at ensuring balanced growth and full employment or through unemployment insurance..." Obviously new jobs are the best answer for those without work, through unemployment insurance..." Obviously new jobs are the best answer for those without work, the meantime, we owe these workers some measure of compassion and justice by extending the federal benefits in the unemployment insurance system.

We believe that coming to the aid of unemployed workers and their families is not only good for the economy; it is the right thing to do. Please act now to avoid the tragic consequences of hundreds of thousands of workers without the vital means of support.
