



Remarks for Conclusion of the Reading Event Monday, January 22, 2001

THE PRESIDENT HAS SEEN 1/22/01

- We had a terrific meeting today with reading experts and the teachers and practitioners who are putting them into practice.
- I want people to know that education will be my priority as President. We must make sure that no child will be left behind in America.
- I am committed to giving every American child the best possible start toward the American dream by teaching every child to read. We are going to have high standards. But we are going to prepare children to meet those standards. We want them to succeed, and we will take practical steps so everyone begins the accountability system on an equal footing.
- My plan will <u>provide added resources</u> to help states and local districts, especially confronting the issue we were discussing today <u>to make sure every child can</u> <u>read</u>.
- We face a national emergency: too many of our children cannot read, particularly our disadvantaged students.
- In the highest poverty schools, 68 percent of fourth graders could not read at basic level in 1998.
- Reading is the gateway to learning and the foundation for all other education reform. We cannot allow ourselves to become two nations -- one that reads, and one that can't. As my friend Phyllis Hunter says, "Reading is the new civil right."
- I am looking forward to working with Congress to pass a comprehensive reading initiative, based on what science tells us works in teaching our children to read.
 - Includes diagnostic tests to identify early reading problems in K-2.
 - Establish a curriculum based on sound research, including phonics.
 - Intensive training for teachers of early grades.
 - Intervention and extra help for those having trouble reading, including summer school and after school programs.
- I have asked these experts joining me today to join me in this effort.

Remarks for Conclusion of the Reading Event Monday, January 22, 2001

- We had a terrific meeting today with reading experts and the teachers and practitioners who are putting them into practice.
- I want people to know that education will be my priority as President. We must make sure that no child will be left behind in America.
- I am committed to giving every American child the best possible start toward the American dream by teaching every child to read. We are going to have high standards. But we are going to prepare children to meet those standards. We want them to succeed, and we will take practical steps so everyone begins the accountability system on an equal footing.
- My plan will <u>provide added resources</u> to help states and local districts, especially confronting the issue we were discussing today <u>to make sure every child can</u> <u>read</u>.
- We face a national emergency: too many of our children cannot read, particularly our disadvantaged students.
- In the highest poverty schools, 68 percent of fourth graders could not read at basic level in 1998.
- Reading is the gateway to learning and the foundation for all other education reform. We cannot allow ourselves to become two nations -- one that reads, and one that can't. As my friend Phyllis Hunter says, "Reading is the new civil right."
- I am looking forward to working with Congress to pass a comprehensive reading initiative, based on what science tells us works in teaching our children to read.
 - Includes diagnostic tests to identify early reading problems in K-2.
 - Establish a curriculum based on sound research, including phonics.
 - Intensive training for teachers of early grades.
 - Intervention and extra help for those having trouble reading, including summer school and after school programs.
