
### **Grain and Oilseed Prices Fall**




# **Net Cash Income**





# I. PURPOSE

To emphasize your message of putting parents in charge and ensure children are not trapped in failing schools as parts of your plan to "leave no child behind."

#### II. BACKGROUND

The audience in the Rose Garden will be mostly low-income, minority parents and education leaders from various states and leaders from the charter school and public school choice movement. This group supports choice and charters.

Under your plan: (1) parents will be enabled to make informed choices about the schools their children attend by having access to school-by-school report cards on student achievement for all groups of students; (2) parents will be able to see if their children are making progress toward state-set standards on an annual basis; and (3) parents will be able to measure the quality of their state standards by having states participate in an annual National Assessment of Educational Progress (NAEP) test.

We are making good, bipartisan progress in bringing people together to empower parents. Both the House and the Senate are considering legislation that would allow Title I funding to follow children after the school has failed to make adequate yearly progress for three consecutive years. In the Senate, negotiators – including Senators Kennedy and Lieberman – have agreed to allow the funding to follow low-income students to the tutoring program of their choice. In the House, HR 1 would allow students to take the funding to the public, private, or religious school of their choice – as you have proposed.

On charter schools, your plan provides funding to assist charter schools with start-up costs, facilities, and other needs associated with creating high-quality schools. Your budget includes \$150 million in additional funding for this program.

Also, under your plan, Education Savings Accounts will be expanded from \$500 to \$5,000 annually and allow parents to use funds for any education-related expense from Kindergarten to college and beyond.

The education event is a two-tier event. You will first meet in the Oval Office with 10 people who actively support choice in education. Following this meeting, you and your guests will proceed to the Rose Garden, where Rev. Floyd Flake will introduce you to an audience of 135, mostly minority parents who support school choice in the education of their children.

# Reverend (Dr.) Floyd Flake (Jamaica, NY) Pastor, Allen AME Church

Rev. Flake is also the President of Edison Schools and a Senior Fellow at the Manhattan Institute. Flake has been a pastor at the 12,000-member Allen AME church for 25 years. Thanks to his leadership, Allen AME has played a leading role in revitalizing Jamaica, Queens. Flake is an outspoken supporter of parental choice. He is a former member of Congress and was the first member of the Congressional Black Caucus to endorse choice.

# Dr. Marthenia Dupree (Coconut Grove, FL), "Tina"

Co-Director, FloridaChild Project and Spokesperson, Floridians for School Choice

Dupree has been involved in promoting School Choice for low-income parents for the past 2-1/2

years. Tina – "The Chicken Lady," as she is commonly referred to – has traveled Florida

speaking and training parents on issues concerning choice in Florida. She is the owner of

Motivational Training Center and has written three books. She is also the Pastor of the United

# The Honorable Dwight Evans (Philadelphia, PA) Pennsylvania House of Representatives

Democrat Appropriations Chairman Dwight Evans was born and raised in Philadelphia and educated in its public school system. Evans championed the state's charter school law and has been the number one volunteer at the West Oak Lane Charter School in Philadelphia since it opened in 1998. He also supported the Education Empowerment Act designed to help students in failing school districts. He is also active in the Philadelphia School District public-private partnership with Community Education Partners to create an alternative school for disruptive students. He is currently focusing his efforts on education reform, teacher recruitment and retention, and increasing educational alternatives for families.

# Dr. Howard Fuller (Milwaukee, WI)

## Director, Institute for the Transformation of Learning

Dr. Fuller is a former superintendent of Milwaukee Public Schools and founder of the Black Alliance for Educational Options, now sponsoring television spots in the Washington, D.C. area. He is a powerful speaker for the need for school choice for low-income kids.

#### Ken Johnson (Milwaukee, WI)

#### Vice President, Milwaukee Public School Board

Ken Johnson is an African-American electrician who ran for the school board to improve public schools but who also believes parents deserve to choose the schools best for their children.

#### Susan Mitchell (Milwaukee, WI)

#### President, American Education Reform Foundation

Susan Mitchell seeks to expand parent choice by working with supporters in selected states. She built a coalition of low-income parents, employers, elected officials, and community activists to expand school choice in Milwaukee.

# Virginia Walden-Ford (Washington, DC)

#### Executive Director, D.C. Parents for School Choice, Inc (DCPSC).

Founded in 1998, *DCPSC* is a clearinghouse organization for parents in Washington, D.C. It organizes and educates parents to empower them to make the appropriate educational decisions for their children. If parents understand school choice, they can advocate badly-needed educational reform. Prior to taking over leadership if *DCPSC*, Virginia served as Community Outreach Director/Media Specialist for Friends of Choice in Urban Schools (FOCUS), an organization supporting the growing Washington, D.C. charter school movement. A single parent, she raised three children in Washington, D.C. Two of her children finished high school in the District, but with her third child she was faced with deteriorating public schools and violence in school. After obtaining a private scholarship for her son to attend a private school, she became an outspoken advocate for school choice.

# Founder and Principal, Cesar Chavez Public Policy Charter High School

Before founding Cesar Chavez, Salcido worked for nine years in the D.C. public school system, six of those as an Assistant Principal at Bell Multicultural High School. Salcido is considered an expert on charter schools. She recently won the "Use Your Life" award from Oprah Winfrey's Angel Network.

#### Gail Hawkins Bush (Philadelphia, PA)

# Chief Administrative Officer, Alliance for Progress Charter School

This is a non-profit, community organization working to promote quality public education for D.C. families through the development of public charter schools.

#### CELEBRATION OF THOMAS JEFFERSON'S BIRTHDAY

#### I. PURPOSE

To celebrate Thomas Jefferson's 258<sup>th</sup> birthday, which is Friday, in an event that will bring together both branches of the Jefferson family in the White House for the first time. You will sign a proclamation in honor of Jefferson's birthday celebrating his enduring legacy.

#### II. BACKGROUND

Friday, April 13, 2001 is Thomas Jefferson's 258<sup>th</sup> birthday. Author of the Declaration of Independence and the Statute of Virginia for Religious Freedom, third President of the United States, and founder of the University of Virginia, Thomas Jefferson voiced the aspirations of a new America as no other individual of his era. As a public official, historian, philosopher, and plantation owner, he served his country for over five decades.

On Thursday, you will sign a proclamation honoring Thomas Jefferson's birthday in the presence of guests and descendants, including both family members from his marriage with Martha Wayles Jefferson and his descendants from Sally Hemings, one of his slaves.

Delegate Paul Harris of Virginia was extremely supportive of this event and recommended we work with the Thomas Jefferson Foundation for a list of both sets of descendants. The Thomas Jefferson Foundation owns and operates Monticello, the mountaintop home of Thomas Jefferson. Incorporated in 1923 after the Federal government waived its third opportunity to acquire Monticello for the nation, the Foundation purchased the house and land. As a private, nonprofit organization, the Foundation receives no ongoing Federal or state funds for its missions of preservation and education.

#### Descendants

Jefferson was married to Martha Wayles Jefferson. Descendants of their two daughters, Martha and Maria, formed a private, nonprofit organization called the Monticello Association, which owns and maintains the cemetery where Jefferson is buried.

The other set of descendants are those believed to be likely descendants from a probable relationship Jefferson had with one of his slaves, Sally Hemings. The Thomas Jefferson Foundation set up a research committee selected from its staff members. The research committee produced a report (the "Committee Report") after the release of the DNA results showing a "strong likelihood" that Thomas Jefferson fathered six children by Sally Hemings.

Although numerous scholars and Dan Jordan, President of the Thomas Jefferson Foundation, have recognized the relationship between the Jeffersons and Hemings, others have not, including some members of the Monticello Association. The claim that Jefferson fathered children with Sally Hemings entered the public arena during Jefferson's first term as President, and has remained a subject of discussion and disagreement for nearly two centuries.

The Thomas Jefferson Heritage Society, in reaction to the Thomas Jefferson Foundation report, established a Jefferson-Hemings Scholars Commission that disputes the Foundation's conclusion that Sally Hemings' heirs are descendants of Thomas Jefferson. They believe the "Committee Report" is a serious example of an assault on historical truth. On April 12, the Jefferson-Hemings Scholars Commission will host a press conference to oppose the "Committee Report" claiming the Hemings to be descendants of Thomas Jefferson.

A Thomas Jefferson actor who performs at Williamsburg will begin the event with a performance of "Meet Thomas Jefferson."

As the White House's latest tenant, it is my pleasure to welcome you back to Thomas Jefferson's former home.

Most people don't realize this, but Thomas Jefferson and I share a hobby. We both like to make up words. According to the Oxford English Dictionary, in fact, Mr. Jefferson contributed more new words to the language than any other U.S. President. I especially like his term for the Barbary pirates: "Barbaresques." But I am also impressed by his words "debarrass" [DEE-bar-rass] and "graffage" [GRAFF-aj].

I don't think "misunderestimate" is quite in Jefferson's league. But I'm doing my best.

As you know, I've been trying to reduce taxes. Thomas Jefferson and I agree here as well. He warned that government must "expend the public money with the same care and economy we would practice with our own, and impose on our citizens no unnecessary burdens." Something for us all to think about.

Jefferson can be quoted by the hour. He lived a long time ago, and yet he still speaks directly to the present. Few former Presidents survive more vividly in our memories. And we feel his presence especially strongly in this place.

This is the room where Jefferson's secretary, Meriwether Lewis, had his office and bedroom – and from which he embarked on his great expedition to the Pacific.

In this house, Jefferson famously wore his carpet slippers to receive the British King's ambassador.

In the Green Room, he delighted his guests with his insights into science, philosophy, law – any subject except what Jefferson called "the hated occupation of politics."

Jefferson holds the American imagination because he articulated the American creed. We declared our independence with his words: that all men are created equal and that they are endowed by their Creator with unalienable rights. Jefferson is the poet laureate of American freedom.

Our world echoes with Jefferson's ideals – even though Jefferson did not always act as if they were true.

The same Thomas Jefferson who wrote the original Ordinance banning slavery in the Northwest territories lived on the labor of slaves. The same Jefferson who denied racial equality spoke ringing words of equal rights. Jefferson profited from slavery – but he gave power to liberty. He doubted the existence of the Christian God – but he trembled for his country when he remembered that the God he doubted was just. He did wrong – but he never lost sight of what was right.

No wonder America sees itself in him. He was what we are – marked by the same faults, inspired by the same ideals.

Jefferson inspires us still. He believed that education was the key to human potential. We must be committed to educating every American child. His Louisiana Purchase threw open the opportunities of this vast country. We must dedicate ourselves to extending opportunity wider and wider. Above all, Jefferson believed in liberty – in the ability of citizens to govern their own country and govern their own lives. We must always affirm this democratic faith.

Like many great men, Thomas Jefferson leaves behind a complex legacy. Tomorrow would have been his 258<sup>th</sup> birthday. On his 358<sup>th</sup> birthday, Americans will still be debating his achievements and his faults – his words and his deeds.

Perhaps the best verdict came from one of Jefferson's keenest admirers and sharpest critics: the first Republican President, Abraham Lincoln. Lincoln was invited in 1859 to come to Boston to speak at a Jefferson birthday event in that city. He was unable to attend and so he put his thoughts in a letter.

At that time, Jefferson was a contentious name in American politics. His memory had been hijacked by slaveholders who distorted many of his

deeds and most of his words. But Lincoln saw further and deeper. When the view beyond that south window was swamp and the stump of the Washington Monument ... when there were no cherry blossoms, no Jefferson Memorial ... no Monticello on the nickel and no Jefferson building for the Library of Congress ... Lincoln could still see the enduring meaning of Thomas Jefferson in American and world history.

# Abraham Lincoln wrote:

"All honor to Jefferson – to the man who, in the concrete pressure of a struggle for national independence by a single people, had the coolness, forecast, and capacity to introduce into a merely revolutionary document, an abstract truth, applicable to all men and all times, and so to embalm it there, that to-day, and in all coming days, it shall be a rebuke and a stumbling-block to the very harbingers of re-appearing tyranny and oppression."

Happy Birthday, Mr. Jefferson.

Now I am honored to sign this proclamation celebrating Thomas Jefferson's birth, and his continuing influence.
