

#### Additional Background on Representative Hansen

Additional background for 10:05 a.m. meeting with Representative James Hansen, Chairman, House Committee on Resources.

The Congressman is likely to raise two important issues. The first is an amendment to the Antiquities Act that Republican Mike Simpson (R-ID) is prepared to introduce, and that Chairman Hansen has co-sponsored. The bill would limit unilateral designations of national monuments by the President to 50,000 acres or less and mandate a 60 day notice provision with public input.

This amendment is the combination of two prior amendments, which passed the House but have yet to be signed into law. The restriction on acreage (50,000) passed 229-197 in the 105<sup>th</sup> Congress, while the 60-day notice amendment passed in the 106<sup>th</sup> Congress with a vote of 408-2. While it has strong support in the House, the Senate is unlikely to bring it up for consideration.

The second topic of discussion will be his proposal to create a National Monument on the site of two hundred million year-old dinosaur footprints in St. George, Utah. The property (approximately 5-50 acres) would be acquired by the Bureau of Land Management with Federal monies already allocated to Utah. Once the property is acquired you would have the authority to create the Dinosaur Tracks National Monument.

Representative Hansen believes this to be an opportunity for the Administration to demonstrate the correct way to use its Antiquities Act authority. He believes the designation will protect a valuable historical resource while relying upon local input and partnerships to develop the proposal.

Time permitting, the Chairman might raise the importance of ANWR and its inclusion in a comprehensive energy bill to be on the House Floor in July.

# Wine Institute Talking Points

#### **Ending the Death Tax:**

- The death tax impedes economic growth because it levies yet another layer of taxes on capital. More capital investment means higher incomes for all workers.
- The punitively high death tax can fall most heavily on small businesses and family farms that are asset rich but cash poor. According to a 1993 survey, nine out of ten successors whose family businesses failed within three years of the owner's death listed the death tax as a contributing factor.
- Wealth would be taxed only when it is earned, not again when entrepreneurs and senior citizens pass the fruits of their labors to the next generation.
- Finally by encouraging intricate planning techniques to reduce taxes, the death tax has created an entire industry of specialized lawyers and accountants.
- I believe that the bias of the death tax against the family farm and family business is the antithesis of the American Dream. Accordingly, my tax relief plan will eliminate the death tax.

### **Energy:**

- I am very concerned about the risk of blackouts in California this summer, which I know is a particular concern to your industry. I am concerned about the impact of blackouts on human lives.
- My Administration has worked from the first day to help California increase supply and conserve electricity use, to help minimize the risk of blackouts.
- We have expedited permits for new power plants and natural gas facilities.
- 4 of the 6 new "peaker" power plants were approved through EPA's expedited permitting.

- I have ordered federal facilities to make the maximum effort to conserve use, especially during peak demand periods. The Defense Department has committed to reduce its use from the grid by 10 percent or enough electricity for over 40,000 homes.
- My energy plan will focus on encouraging new, cleaner electric generation and transmission infrastructure. The difficulties your state has had moving power from the south of the state to the north, through "Path 15", illustrate to me the need we have to expand our nation's electric grid capacity.
- Short term or long term, the only responsible policies are ones that increase supply or reduce demand. I oppose price caps because they would discourage supply and do nothing to conserve electricity use. I am concerned that price caps would make blackouts in your state more likely than they already are this summer.
