Bush plan will face potent foe

The largest senior lobby opposes changing Social Security to allow private accounts.

WASHINGTON - Bill Novelli doesn't like headlines that frame the debate over Social Security as a "clash of titans" - his own 35.6 million-member AARP, of which he is CEO, versus the Bush administration. He says President Bush has done a "very good thing" by putting Social Security on the national agenda.

But as the Democratic Party still finds its way in a world of larger Republican majorities in Congress and a second Bush term in the White House, the nation's largest lobby group for senior citizens has become the de facto leader in the battle to preserve what it considers essential elements of the program.

As the Bush White House and key Republican leaders discuss the twin goals of ensuring Social Security's longterm solvency and promoting the concept of an "ownership society" by allowing workers to put some of their payroll taxes into personal or private accounts, the plan that AARP is developing may end up being the lead alternative.

"We are not interested in confrontation with any party or any administration. We are interested in cooperation," Mr. Novelli told reporters at a Monitor breakfast Monday. "But having said that, we are dead set against carving private accounts out of Social Security money, and this is our No. 1 legislative agenda."

The AARP can back up such assertive language with a membership that, over the years, has put fear in the hearts of politicians of both parties - and backs up its views by voting in large numbers.

Two years ago, the AARP was a key administration ally in the battle to add a prescription-drug benefit to Medicare, a program that so far has not proved popular with seniors. So the AARP has an added incentive to fight the administration on Social Security, analysts say.

"Large numbers of [AARP] members saw working with the White House on the prescription-drug bill that came out as the equivalent of sleeping with the enemy," says Norman Ornstein, a resident scholar at the American Enterprise Institute in Washington. "They were willing to leave them in place through one transgression, but they would be tarred, feathered, and ridden out of town on rails if they did it a second time."

Still, Mr. Ornstein agrees, it is highly likely the AARP would have opposed the administration's concept for Social Security reform in any case, since it represents a fundamental departure from the original concept 70 years ago of providing a guaranteed retirement benefit to workers.

The administration believes allowing younger workers to divert some of their payroll taxes into private investment accounts would ultimately provide a higher rate of return than if all the money stayed in the public system. The AARP considers the idea risky and expensive, given the vagaries of the stock market and the behavior of some investors.

John Rother, AARP's policy director, said at the breakfast that partial privatization of Social Security would risk a rerun of the nation's experience with 401(k) accounts, where a majority of people take money out prior to retirement.

Transition costs for partial privatization have been pegged at between \$1 trillion and \$2 trillion over 10 years, which opponents of personal accounts say is too big a burden given the skyrocketing budget deficit. Proponents of personal accounts liken the costs to refinancing a mortgage: big costs up front, in the name of financial benefits over the long run.

For AARP, the lessons of the prescription-drug episode are still fresh.

"One thing is that, as much research as we did among our members, there were still plenty of members who said, 'You didn't ask me,' " says CEO Novelli. "We are going to do a better job now of reaching out to them, of informing them, of having a dialogue with these members."

It is this "reaching out" that makes some Republicans uneasy. On "Meet the Press" on Sunday, Rep. Bill Thomas (R) of California, chairman of the House Ways and Means Committee, accused the AARP of spending tens of millions of dollars "to simply scare people."

Novelli would not put a dollar amount on what AARP will spend on outreach to its members and the public in general, but he denied that the goal is to scare people. "In fact," he added, "we are going to be reaching out more and more to younger people, people under the age of 50 ... and essentially educating them on the Social Security issue as well."

The AARP released a poll Monday of 1,500 adults age 30 and over, finding that if given a choice, 3 in 5 would strengthen Social Security with as little change as possible. Mr. Bush, the GOP, and outside groups, for their part, are already reaching out to the public to support the Bush agenda through the 2005 version of what came to be known during the Clinton years as the "permanent campaign." Bush himself is expected to lobby Congress and make speeches around the country, while outside groups purchase TV ads and the party mobilizes grass-roots support via e-mail and other forms of personal contact.

As Benefits For Veterans Climb, Military Spending Feels Squeeze Congress's Generosity May Hurt Weapons, Other Programs; Lobby Group's Power Grows

WASHINGTON -- With the wars in Iraq and Afghanistan badly straining its forces, the Pentagon is facing an awkward problem: Military retirees and their families are absorbing billions of dollars that military leaders would rather use to help troops fighting today.

Congress, pressured by veterans groups, has in recent years boosted military pensions, health insurance and benefits for widows of retirees. Internal Pentagon documents forecast that the lawmakers' generosity since 1999 will force the federal government to find about \$100 billion over the next six years to cover the new benefits.

"The amounts have gotten to the point where they are hurtful. They are taking away from the nation's ability to defend itself," says David Chu, the Pentagon's undersecretary for personnel and readiness.

Rising veterans' benefits are a big factor behind the billions of dollars in weapons cuts to be proposed when President Bush unveils next year's budget blueprint early next month. New retiree entitlements also are crimping the Pentagon's ability to increase incentives for enlistment at a time of dangerous, yearlong Iraq deployments.

The military's budget woes are similar to the broader problem facing the U.S. government, as spending on aging baby boomers -- in the form of Social Security and Medicare -- squeezes out funds for other programs, from health care for the poor to scientific research. The pinch is exacerbated by Mr. Bush's campaign promise not to raise taxes. The private sector, particularly auto makers and the steel industry, is being similarly squeezed. Many companies are holding the line and in some cases cutting spending on pensions and health care for future retirees.

The Pentagon, which faces an increasingly aggressive and effective veterans lobby, doesn't have that luxury. The main force among veterans groups has been the Military Officers Association of America, an Alexandria, Va.based group boasting about 400,000 dues-paying members and a board packed with retired generals and admirals.

MOAA has an ambitious agenda for 2005, listing on its Web site 16 goals for further expanding retiree and survivor benefits. Earlier this month, its members flooded Capitol Hill with about 16,000 brown bags with hand-written messages urging lawmakers to exempt World War II and Korean War retirees from Medicare premium payments. The message: Veterans were being treated like old paper bags to be discarded after use.

"We in the military have long had pay scales below our civilian counterparts," says retired Vice Adm. Norb Ryan, the MOAA's president. In exchange, the military offered troops a generous retirement and health-care package. "Now some in the Pentagon want to walk away from that. That is a very dangerous thing," Adm. Ryan

says.

The politics of veterans benefits, meanwhile, are roiling the Republican Congressional majority. Earlier this month, the House Republican leadership took the unusual step of stripping New Jersey Rep. Christopher Smith of his chairmanship of the Veterans Affairs Committee. Mr. Smith had irked House leaders when he pushed so aggressively for veterans benefits that he at times threatened to oppose their spending plans -- and President Bush's -- unless more retiree benefits were included.

Big Shift

The rise of the veterans lobby marks a dramatic shift in modern military spending. "If you look back to the history of the all-volunteer force going back to 1973, the Congress has in general deferred to the executive branch on major pay and benefit changes," says Dr. Chu.

That began to change in the late 1990s, when veterans groups charged that the federal government was reneging on promises made by recruiters in the 1940s and '50s to provide free cradle-to-grave medical care to military retirees who served a 20-year career. They took out ads on the radio and flooded newspapers with letters to the editor saying the military was letting down the "Greatest Generation."

"There was tremendous emotion. These groups were highly organized," says retired Gen. Jack Keane, who was on active duty at the time. Senior military officers worried the widespread allegations of broken promises from veterans groups were hurting military recruiting, recalls Gen. Keane. Many officers, including Gen. Keane himself, sympathized with the retirees.

Over the objections of the Clinton Pentagon, but with the support of then-Joint Chiefs Chairman Gen. Henry Shelton, Congress in 2000 opened the military's generous health-care program to over-65 retirees who in the past had been forced to rely solely on Medicare. The change will cost the federal government more than \$8 billion for this fiscal year ending Sept. 30, the Pentagon says. Lawmakers also changed the military retirement system to allow troops with 20 years of service to collect 50% military pay upon retirement instead of 40%.

Almost every year since then Congress has pushed through billion-dollar increases in personnel benefits. The projected growth in retiree benefits of the next six years dwarfs the \$55 billion in cuts to new fighter jet, ship and submarine programs proposed by the Bush administration in December and spread out over the same six-year period.

The largesse has grown with the wars in Iraq and Afghanistan, which mark the first time in the past century that the U.S. has had to wage sustained combat with an all-volunteer force. Members of Congress use any opportunity to see off soldiers or welcome them home. "The first question the lawmakers ask is, 'What can we do for you?' Then they do it," says one senior Army official.

The sharp reductions in the number of World War II, Korea and Vietnam veterans serving in Congress and in the top ranks of government may help explain some of the veterans groups' influence. Lawmakers who didn't serve in the military are more apt to be intimidated by veterans groups, says Tom Philpott, an expert on military benefits who writes a syndicated column on the subject for several military Web sites and newspapers. "I think there is a guilty conscience among those who didn't serve. They say to themselves, 'I didn't serve. But I am sure as heck not going to short-sheet those who have,' " he says.

In each of the 2003, 2004, and 2005 budgets, Congress passed a series of laws allowing severely disabled retirees to collect both their retirement and disability pay. In the past, retirement pay was reduced, dollar for dollar, by disability compensation. The benefit change will cost about \$700 million in 2006 and will rise to about \$3 billion a year in 2013, the Pentagon says.

In the 2005 budget passed last fall, lawmakers came to the aid of 250,000 military widows like 70-year-old Betty Wells, at a 10-year cost of about \$7.5 billion.

Because Ms. Wells's husband made regular payments into the Pentagon's survivor benefit program, she thought she would receive about 55% of his retirement check after he died. Upon her husband's death in 2002 she was shocked to learn that because she already received Social Security she was entitled to a smaller share. Instead of \$2,000 a month, she received about \$1,300. "My goodness, all of a sudden I had to get...back to work," says the Ocala, Fla., real-estate agent. Other widows have testified before Congress that they had to turn to local charities to make up the difference when their checks were reduced.

Veterans claimed that participants in the program weren't adequately told about the Social Security offset when they signed up. Congress ordered the Pentagon in the 2005 defense budget to pay widows the full 55% starting in 2008.

Also in the 2005 budget, lawmakers opened up the military health-care system to reservists who recently served on active duty. For every 90 days deployed overseas, reservists can now buy at a steep discount a year's worth of health insurance, provided they remain in the reserves.

New Obligations

Beyond lawmakers' additions, the private sector's push to trim benefits for employees is in some cases forcing the Pentagon to assume new and unexpected costs. As private-sector firms ask employees to pay larger health-care premiums, a growing number of younger veterans are opting for military health insurance.

The military's health-insurance system, Tricare, has charged families the same \$38 monthly premium since 1995. Over the same period of time, private-sector premiums for families who buy health insurance through an employer have surged 70% to about \$210 a month.

Michael Lynch retired as a Marine Corps lieutenant colonel earlier this month and took a job with a government contractor. He compared the cost of buying health insurance through his employer with the cost of Tricare and chose the government plan. "Tricare's benefits were very similar to my employers. But the cost was much, much less," says Col. Lynch, who is married with two daughters.

Today retirees account for about 50% of all Tricare beneficiaries, up from 40% in 2000. To cover the cost of these new enrollees, the Pentagon has had to shift about \$2 billion a year into its health-care accounts primarily from new weapons-program accounts. "It is quite painful to reallocate that money," says Dr. Chu.

Pentagon officials estimate that by decade's end, new legislation passed by Congress or pending on Capitol Hill will increase the amount of money going to U.S. troops and military retirees by about \$28.6 billion a year. By comparison, new legislation added by Congress boosted the Pentagon's \$100 billion personnel budget by less than \$1 billion in each of the years 2001 and 2002.

Dr. Chu says the military could recruit more troops for less money if it slowed the growth of deferred benefits and paid more cash. About 60% of military pay is tied up in noncash compensation, like pensions, generous health-care benefits, subsidized food and housing.

"I'd like to believe 19-year-olds paid attention to their annuity package," says Dr. Chu. But they don't. "Nineteen-year-olds want cash to buy a pickup truck," he says.

To boost recruiting, the Defense Department recently tripled re-enlistment bonuses for reservists and national guardsmen to \$15,000 from \$5,000. It also raised the amount of money that deployed troops get for serving away from their family in a war zone to \$475 a month from \$125 a month.

As personnel benefits continue to grow, former Pentagon budget chief Dov Zakheim, who stepped down last year, says the Pentagon increasingly finds itself "caught in a vise." Congress won't allow the Pentagon to cut benefits to retirees and deficit pressures make it unlikely that the Pentagon will continue to see its overall budget grow.

Pentagon officials say that with the country at war, cutting maintenance and training isn't an option either. "The only place you can cut is acquisition and research and development," Dr. Zakheim says. Amid this standoff, Pentagon officials say that further cuts to big-ticket weapons systems, like ships, fighter jets and the replacement to the current Army battle tank, are inevitable.

Meanwhile, the military is bracing for more fights in the coming Congress over benefits. There's the brown-bag push to exempt retirees from monthly Medicare Part B premium payments. The payments, which amount to about \$80 a month, cover the cost primarily of doctor visits and are required even if veterans are covered by the military health-care system. Veterans groups insist these World War II and Korean War vets were promised free health care for their service. "This is a matter of principle for these guys," says Adm. Ryan.

MOAA is also pressing lawmakers to repeal a law that reduces the pensions of widows who receive a \$1,000-amonth check because their husbands died of a service-related cause. The cost: about \$400 million a year. And it's trying to lower the age at which reservists can begin collecting their military pensions to 55 from 60.

Reservists say that change is needed to compensate them for their time on active duty. Lt. Col. Doug Trogstad, who pilots a cargo plane in the Air Force Reserve and also works for Northwest Airlines, has spent the past two years flying missions into Iraq for the Air Force. "I have been deployed more than most active-duty troops," he says. While on active duty he has taken a substantial pay cut and has been unable to contribute to his retirement fund. "I never believed the government was fair. But it should at least be equitable," he says.

Pentagon officials say that change comes with a \$1 billion-a-year bill and will do little to help with recruiting or retention problems. In fact, Dr. Chu says, the change would lead about 25,000 older reservists to retire early. "We would pay \$1 billion a year and get negative retention. It is a caricature of what is going on," he says.

On behalf of the veterans of this nation I resent Dr. David Chu's implication that veterans are nothing more than greedy pigs feeding off the government trough. His remark about veterans' pay and benefits that "the amounts have gotten to the point where they are hurtful. They are taking away from the nation's ability to defend itself," is a slap in the face to every veteran who took the oath to uphold and defend the constitution against all enemies.

Greg Jaffe's report that one VSO had a "board packed with retired generals and admirals" did a disservice to the real story. Generals, admirals, privates and seamen didn't join the service to become millionaires. There are officers and enlisted troops sweltering in 130-degree temperatures, dodging enemy fire and praying for the day they will come home safely to their families. GI Joe and Jane have given all they have in this war and all the wars of the 20th century. They are not getting rich on what Dr. Chu seems to think is a gravy train.

To date, America has spent well over \$200 billion on battling terrorism in Iraq and Afghanistan. Dr. Chu seems to think that \$2 billion for VA health care in FY 2005 and \$6 billion to modernize the VA health care system is too much. Countless billions have been spent on wars past but precious little on those who fight for America's freedom. Just 4 percent of the money spent on the war on terrorism would provide the vital health care and benefits so richly earned by veterans of all wars.

Pitting veterans against those currently serving in the war on terrorism is just plain wrong. Veterans' health care and benefits are a delayed cost of war. Caring for veterans is not a matter of economics but a moral contract. Providing therapy for an E-4 that lost both legs in Iraq; treating the Vietnam veteran suffering from the effects of Agent Orange; treating the diseases of our "atomic veterans," or those of the "greatest generation, or the Korean "forgotten" war are responsibilities we, as a nation, must bear. All gave their best - some gave their last - when their country called and they

deserve the best our country can give them. This is the contract that citizens of this nation understand. This is the contract that all Americans want.

During the war in Viet Nam, our country chose 'guns and butter' spending. That proved to be a fiscal disaster. We had neither enough guns nor enough butter. As a nation at war, we must prioritize national spending starting with national defense and veterans health care. Everything else is secondary.

The 2.7 million men and women of The American Legion will continue to fight for a strong DoD budget as we always have. But our country cannot separate military retirees from veterans. A veteran is a veteran. There is no separation of ranks. Whether that veteran is an officer or an enlisted member or a noncommissioned officer, they share a common bond - the defense of our country.

America has never begrudged the expense of taking care of our men and women in uniform who, as President Lincoln stated in 1865, "shall have borne the battle, and for his widow, and his orphan." These words are inscribed on the Department of Veterans Affairs Building in Washington D.C.

It is a charge we must not ignore.

Yesterday was the day for the Senate leadership to release their "Top Ten" legislative issues, traditionally done at the start of each new Congress by the majority party. Senate Majority Leader Bill Frist (R-TN) presented the list, which included important issues to family groups, such as welfare and tax reform. The Time is Now

With the Inauguration behind us and Congress back to work, there is a new opportunity to move important pro-life bills through Congress. The House of Representatives has a pro-life majority, the number of pro-life senators has increased, and the President has reaffirmed his pro-life convictions. Three high-priority pro-life bills are the Unborn Child Pain Awareness Act; the Child Custody Protection Act, and amendments to limit federal funding of abortion. The Unborn Child Pain Awareness Act would require information to be given to the mother about the pain the unborn child experiences during an abortion twenty weeks or later after conception. The Child Custody Protection Act would protect state parental notification laws from being circumvented by transporting minors to neighboring states without protective laws. These are modest but important steps in the battle to defend the sanctity of life by focusing on the humanity of the unborn, and they merit a place on the fast t! rack as Congress gets down to serious business.

Dear Karl,

Pro-family leaders from across the country are in Washington, D.C. this week to observe and celebrate the Inauguration of President Bush to a second term. We arrived filled with hope and anticipation about what the President can accomplish over the next four years. We believe he has an historic opportunity to strengthen our nation, our families and to provide security for our children. We are anxious to encourage millions of pro-family Americans to stand with the President in this effort.

We are particularly optimistic about the improved chances we have to preserve marriage as the union of one man and one woman through a Constitutional Amendment. Great progress was made toward this goal in November. Voters chose the President who supported the amendment over Senator Kerry who did not. A dozen states with referenda on the issue voted overwhelmingly for traditional marriage. Many more will do so in the months ahead. The new U.S. Senate represents a shift of at least five votes in our direction.

We trust then that you can imagine our deep disappointment in the defeatist position President Bush demonstrated in a weekend interview published in the *Washington Post*. The President cited resistance in the Senate to passing a Constitutional Amendment and appeared to accept the excuse that no action was possible unless the Defense of Marriage Act was struck down. He even declined to answer a simple question about whether he would use his bully pulpit to overcome this Senate foot dragging. This comes on the heels of the President's interview a few weeks before the election on which he appeared to endorse civil unions.

We couldn't help but notice the contrast between how the President is approaching the difficult issue of Social Security privatization where public opinion is deeply divided and the marriage issue where public opinion is overwhelmingly on his side. Is he prepared to spend significant political capital on privatization but reluctant to devote the same energy to preserving traditional marriage? If so, it would create outrage with countless voters

Backers of Gay Marriage Ban Use Social Security as Cudgel

ASHINGTON, Jan. 24 - A coalition of major conservative Christian groups is threatening to withhold support for President Bush's plans to remake Social Security unless Mr. Bush vigorously champions a constitutional amendment banning same-sex marriage.

The move came as Senate Republicans vowed on Monday to reintroduce the proposed amendment, which failed in the Senate last year by a substantial margin. Party leaders, who left it off their list of priorities for the legislative year, said they had no immediate plans to bring it to the floor because they still lacked the votes for passage.

But the coalition that wrote the letter, known as the Arlington Group, is increasingly impatient.

In a confidential letter to Karl Rove, Mr. Bush's top political adviser, the group said it was disappointed with the White House's decision to put Social Security and other economic issues ahead of its paramount interest: opposition to same-sex marriage.

The letter, dated Jan. 18, pointed out that many social conservatives who voted for Mr. Bush because of his stance on social issues lack equivalent enthusiasm for changing the retirement system or other tax issues. And to pass to pass any sweeping changes, members of the group argue, Mr. Bush will need the support of every element of his coalition.

"We couldn't help but notice the contrast between how the president is approaching the difficult issue of Social Security privatization where the public is deeply divided and the marriage issue where public opinion is overwhelmingly on his side," the letter said. "Is he prepared to spend significant political capital on privatization but reluctant to devote the same energy to preserving traditional marriage? If so it would create outrage with countless voters who stood with him just a few weeks ago, including an unprecedented number of African-Americans, Latinos and Catholics who broke with tradition and supported the president solely because of this issue."

The letter continued, "When the administration adopts a defeatist attitude on an issue that is at the top of our agenda, it becomes impossible for us to unite our movement on an issue such as Social Security privatization where there are already deep misgivings."

The letter also expressed alarm at recent comments President Bush made to The Washington Post, including his statement that "nothing will happen" on the marriage amendment for now because many senators did not see the need for it.

"We trust that you can imagine our deep disappointment at the defeatist position President Bush demonstrated" in the interview, the group wrote. "He even declined to answer a simple question about whether he would use his bully pulpit to overcome this Senate foot-dragging."

The letter also noted that in an interview before the election Mr. Bush "appeared to endorse civil unions" for same-sex couples.

The group asked Mr. Rove to designate "a top level" official to coordinate opposition to same-sex marriage, as a show of commitment.

Trent Duffy, a spokesman for the White House, said on Monday that "the president was simply talking about a situation that exists in the Senate, not about his personal commitment or his willingness to continue to push this issue." Mr. Duffy said the "president remains very committed to a marriage amendment" and added, "We always welcome suggestions from our friends."

Some Senate Republican leaders were not optimistic on Monday about the amendment's prospects this year.

"I think if we had the vote right now we'd come up short," said Senator Rick Santorum, the Pennsylvania Republican who is a member of the leadership and one of the amendment's most vocal backers in Congress. "We'd like to bring it up when we have the best possible chance of getting it passed."

The members of the coalition that wrote the letter are some of Mr. Bush's most influential conservative Christian supporters, and include Dr. James C. Dobson of Focus on the Family, the Family Research Council, the Southern Baptist Convention, the American Family Association, Jerry Falwell and Paul Weyrich.

Several members of the group said that not long ago, many of their supporters were working or middle class, members of families that felt more allegiance to the Democratic Party because of programs like Social Security before gravitating to the Republican Party as it took up more cultural conservative issues over the last 20 years.

Tony Perkins, president of the Family Research Council, declined to talk about the letter, but said, "The enthusiasm to get behind his proposals is going to require that he get behind the issues that really motivated social conservative voters."

Asked to estimate the level of discontent with the White House among the group on a scale from one to 10, Mr. Perkins put it at 8.

Re: Seeking Approval from Congress to Drill in the ANWR

Dear Mr. Rove:

If the Royalties to be derived by the Federal Government from oil or gas produced in the ANWR were earmarked for Social Security, and possibly a small amount to environmental protection, it is possible that drilling approval may more easily be obtained from Congress.

With oil prices today, and certainly the possibility of higher prices by the time of ANWR production, the royalty income to the Federal Government should be a welcome infusion to the Social Security System.

As you are aware, the most comprehensive study of potential oil production from the ANWR was prepared by the EIA of the U.S. Department of Energy "with plausible scenarios for ANWR supply development consistent with the most recent U.S. Geological Survey resource assessments".

The public, and probably many members of Congress, are unaware of the content of the EIA ANWR report and the estimated details it presents. Following are four of the most important points:

- 1. "7 to 12 years would be needed for lease sales, permitting and environmental reviews after approval for leasing". The USGS uses <u>9 years in its estimates before drilling could begin.</u>
- 2. "Production peaks around 20-30 years after the onset of development in all cases".
- 3. Peak daily production estimates for the USGS scenarios are 650,000 BOPD to 1,900,000 BOPD. The Mean Case scenario daily rate is 1,000,000 BOPD to 1,350,000 BOPD

Events include cultural festivals and symposia; an observance in December 2007 in England to mark the launching of the three ships, a series of forums on the Future of Democracy; Virginia being featured at the 2007 Smithsonian Folklife Festival in Washington, DC; and a grand "Anniversary Weekend" in Jamestown in May 2007. A civics curriculum focused on the development of American democratic institutions is also being developed. The Federal Commission is acting as liaison with governmental and private agencies in the United Kingdom through the British Jamestown 2007 Committee.
