Scope and Content

FOIA 2020-0091-F requested materials related to video footage of President George W. Bush at Emma E. Booker Elementary School on September 11, 2001.

This FOIA contains video footage of President George W. Bush participating in a reading program demonstration in a classroom as well as delivering remarks to parents and teachers regarding the day's terrorist attacks.

System of Arrangement

The materials in FOIA 2020-0091-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
