The following two questions have been raised about delivery of the invites to the political appointees for the reception hosted by the RNC.

1)Dept. of State asked if they can send an e-mail to the people who are to receive an invite letting them know they have an invitation to pick up in the White House Liaisons Office. The problem with giving it to someone who handles the mail regularly in this case is that their internal mail system is not reliable with it taking up to 3 weeks for mail to be delivered. If their proposal is not ok, what would you propose they do?

2)Conan French,the USAID mentioned that their political appointees had further restrictions on allowable political activities -- I mentioned to them that he should either talk to you or his general counsel to get guidance.
