After this week, President will have made 85 nominations so far this year, including 31 re-submits in January and 54 new nominations. Unfortunately, as of this week, the Senate will have 67 judicial nominees pending before it, which is an extraordinary number. That includes 23 pending circuit noms and 44 pending district noms. Senate needs to get to work. It has confirmed only 2 circuit noms and 16 district noms so far this year.
