General Considerations:

We interviewed Mr. Campbell more than a year ago for a vacancy on the district court in Arizona and thought he was outstanding. Justice Fred Martone of the Arizona Supreme Court, who also was top-notch, ultimately was nominated and confirmed to that district court seat. There is a new vacancy created by the recent judgeship bill, and we recommend Mr. Campbell. He is a very experienced litigator and quite well-respected in Arizona. He has been involved in numerous bar and community activities and also has taught as an adjunct professor. We expect him to be a superb federal trial judge who will interpret and apply the law as written. We also expect him to be a very strong candidate for future elevation to the Ninth Circuit; indeed, he is the best future Ninth Circuit candidate from Arizona of whom we are currently aware.
