### **President Bush's Nominee to the United States Court of Appeals for the Fifth Circuit**

- Edward C. Prado now serves as a United States District Judge for the Western District of Texas. He has more than 18 years of federal judicial experience and has handled hundreds of trials, both civil and criminal. Judge Prado has served as a federal district judge since his appointment to the federal bench by President Reagan in 1984.
- Prior to becoming a federal judge, Judge Prado served as the United States Attorney for the Western District of Texas, from 1981 to 1984.
- Judge Prado served as a Judge of the 187th District Court during 1980, having been appointed to the post by Governor Bill Clements.
- Judge Prado also served as an Assistant Federal Public Defender, from 1976 to 1980, and as an Assistant District Attorney for Bexar County, from 1972 to 1976.
- In 1991, Chief Justice Rehnquist appointed Judge Prado as Chairman of the Committee to Review the Criminal Justice Act, which performed an extensive study of the representation of indigents in federal court.
- Every year since 1994, Judge Prado has hosted inner-city elementary school children in his courthouse for "Miracle on Durango Street" -- a mock trial presided over by Judge Prado involving the trial of Santa Claus.
- The awards and honors Judge Prado has received include: the St. Thomas Moore Award, St. Mary's University School of Law (2000); the LULAC State Award for Excellence (1981); inclusion in the Edgewood I.S.D. Hall of Fame (1981); being named Outstanding Young Lawyer of San Antonio (1980); and being named Outstanding Federal Public Defender, Western District of Texas (1978).
- Judge Prado's community activities include involvement with the Witte Museum Community Advisory Committee and Leadership San Antonio. He is a member of St. Mark's Catholic Church.
- Judge Prado received both his undergraduate degree and his law degree from the University of Texas at Austin, in 1969 and 1972, respectively. He is also a graduate of Edgewood High School and San Antonio Junior College.
- Judge Prado, 55, was born and still lives in San Antonio. He and his wife, Maria Anita Prado, have one son.
