Scope and Content

FOIA 2017-0429-F requested materials from Keith Hennessey, Brian Reardon, Allan Hubbard, or Steve Friedman from the National Economic Council concerning the Homeland Investment Act, also referred to as Section 422: Incentives to Reinvest Foreign Earnings in the United States of the American Jobs Creation Act of 2004 – H.R. 4520.

This FOIA primarily contains analyses of the proposed act, discussions regarding the Administration's position on provisions within the legislation, emails to schedule meetings, correspondence with the business community and Congress, memoranda about the legislation,

Statements of Administration Policy and drafts thereof, and comparisons of H.R. 4520 to its Senate equivalent, S. 1637.

System of Arrangement

The materials in FOIA 2017-0429-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) processed in response to FOIA 2017-0429-F:

George W. Bush Electronic Records

ARMS contains 41 assets, of which 34 are released in full, 5 are withheld in part, and 2 are withheld in full.

Exchange contains 523 assets, of which 445 are released in full, 27 are withheld in part, and 51 are withheld in full.

40 Days contains 10 assets, all of which are released in full.

NEC Share contains 8 assets, all of which are released in full.

Hennessey Share contains 1 asset, which is released in full.

RNC-PST contains 3 assets, all of which are released in full.
