Access

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2018-0056-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0056-F requested materials related to any personal meetings, calls or other activities between Haley Barbour and President George W. Bush that occurred in 2002 and 2003.

This FOIA primarily contains speech drafts, schedules, trip books, briefing papers, event background information and memoranda, biographies of participants, internet printouts, a recommended telephone call memorandum, a memorandum for Karl Rove from Haley Barbour, correspondence between the White House and Haley Barbour, the Presidential Daily Diary and Backup, movement logs, and call logs. Electronic records consist of schedules, White House news clips and articles, scheduling and administrative emails, web transcripts of speeches,

Worker and Visitor Entry System (WAVES) records, press gaggles and press schedules, photo requests, a recommended telephone call memorandum, and requests from the Haley Barbour campaign. Many of these materials relate to two trips President George W. Bush took to Mississippi on September 12, 2003 and November 1, 2003.

System of Arrangement

The materials in FOIA 2018-0056-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files, Staff Member Office Files, and George W. Bush Presidential Electronic Records.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) and folders processed in response to FOIA 2018-0056-F:

George W. Bush Electronic Records

ARMS contains 225 assets, of which 206 are released in full, 6 are withheld in part, and 13 are withheld in full.

Exchange contains 1,302 assets, of which 947 are released in full, 131 are withheld in part, and 224 are withheld in full.

Exchange 21 Days contains 4 assets, all of which are released in full.

Exchange 33 Days contains 15 assets, of which 13 are released in full, and 2 are withheld in full. RNC contains 78 assets, of which 74 are released in full, and 4 are withheld in part.

OA contains 16 assets, all of which are released in full.

2018-0056-F

OPD contains 1 asset, which is released in full.

WHO contains 108 assets, of which 51 are released in full, 43 are withheld in part, and 14 are withheld in full.

WAVES contains 9 assets, all of which are withheld in part.
