FOIA 2019-0082-F requested textual National Security Council (NSC) materials related U.S.-French relations in the African Great Lakes region.

This FOIA primarily contains newspaper and journal articles, maps, routine memoranda, National Security Council (NSC) profile sheets, lists of meeting participants, printed e-mails, and press releases. Also included are copies of the Tripartite Agreement on Regional Security in the Great Lakes amongst the Democratic Republic of Congo, the Republic of Rwanda, and the Republic of Uganda.

System of Arrangement

The materials in FOIA 2019-0082-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
