Copyright

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2014-0288-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2014-0288-F requested materials related to internal summaries of requests from members of Congress sent to the White House.

This FOIA primarily contains weekly legislative correspondence reports, routing memoranda, correspondence, and printed material. These reports are summarized in routine memoranda from the Assistant to the President for Legislative Affairs to the President. Correspondence topics from members of Congress include, but are not limited to, federal funding of stem cell research, privatization of social security, immigration policy, the energy crisis, the financial crisis, economic sanctions on Pakistan and India, the September 11th terrorist attacks, weapons of mass

destruction, the Global War on Terror, NSA wiretapping and surveillance, the war in Iraq, judicial nominations, global warming, the farm bill, budget and appropriations, healthcare, the steel industry, defense authorizations, creation of the Department of Homeland Security, the Patriot Act, Medicare and prescription drug coverage, the energy bill, and college education.

System of Arrangement

The materials in FOIA 2014-0288-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Staff Member Office Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
