Scope and Content

The materials in FOIA 2018-0189-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0189-F requested materials related to emails regarding Barbara Bush sent by Andrew Card, Karl Rove, Joshua Bolten, or Condoleezza Rice.

This FOIA primarily contains emails discussing possible 2003 Medal of Freedom recipients, a note passed on by a member of George H.W. Bush's staff conveying policy opinions from Peter Teeley, emails about events that Barbara Bush was invited to or attended, and quotes from Barbara Bush about the George W. Bush Childhood Home in Midland, Texas.

Please note that a portion of classified records related to this request has not yet been processed.

Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2018-0189-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) processed in response to FOIA 2018-0189-F:

George W. Bush Electronic Records

ARMS contains 8 assets, of which 2 are released in full, 5 are withheld in part, and 1 is withheld in full.

Exchange contains 36 assets, of which 15 are released in full, 6 are withheld in part, and 15 are withheld in full.
