Scope and Content

FOIA 2019-0274-F requested electronic materials related to Andrew Card with subject lines of Kosovo, Kosovo Liberation Army, Macedonia, Former Yugoslav Republic of Macedonia, Yugoslavia, Serbia, Serbia-Montenegro, NLA, National Liberation Army, Ali Ahmeti, Skopje, Southern Serbia, Presevo Valley and UCPMB from January 21, 2001 - September 30, 2001 and November 1, 2004 - November 20, 2004.

This FOIA primarily contains copies of a press background briefing on President George W. Bush's meeting with Macedonian President Trajkovski by a Senior Administration Official on

May 2, 2001 and a memorandum to Andrew Card from Bradley Blakeman regarding a military air request for a site survey in June 2001.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2019-0274-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
