Scope and Content

The materials in FOIA 2017-0132-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2017-0132-F requested records from the White House Office of Records Management (WHORM) related to Donald J. Trump.

Please note that this request does not include any materials directly to or from Donald Trump. That material is included in the requests listed under the Related Collections and FOIA Requests section of this finding aid. This request only contains mentions of Trump.

This FOIA primarily contains correspondence, invitations, routing memos, published articles, printed emails, administrative documents, forms, and barcode scanning sheets. Responsive

documents include correspondence that mentions Donald Trump, published articles that mention Trump, and a variety of documents that mention Trump as a donor to various events or organizations, a contributor to autograph or doodle collections, or as an honoree or attendee at specific events. There are some mentions related to the television show *The Apprentice* as well as Trump's ownership of numerous casinos. Trump is used as an example of a famous or wealthy person in serval documents, including polling reports. Also included in this request are draft and final presidential greetings, draft and final letters from President George W. Bush to individuals and groups, background information on the recipients of letters and messages, vetting documents, and other administrative documents relating to the sending of letters and messages.

System of Arrangement

The materials in FOIA 2017-0132-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.
