#### **Scope and Content**

The materials in FOIA 2018-0106-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0106-F requested materials related to the drafting and sending of Grant M. Dixon's cease-and-desist letter to the online satirical website, *The Onion*, over their misuse of the Presidential Seal.

This FOIA primarily contains correspondence, memoranda and emails alerting Mr. Dixon to the misuse of the seal by *The Onion*, a copy of the letter sent by Mr. Dixon, and staff discussions concerning *The New York Times* article along with related press on the subject. Included are letters from counsel for *The Onion* Rochelle H. Klaskin and *The Onion* Editor-in-Chief Scott Dikkers to Associate Counsel to the President Grant Dixon in response to his cease-and-desist

letter.

# **System of Arrangement**

The materials in FOIA 2018-0106-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files and George W. Bush Presidential Electronic Records.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
