Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Scope and Content**

The materials in FOIA 2019-0033-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2019-0033-F requested materials related to the phone call between President George W. Bush and President Eduardo Duhalde in January 2002.

This FOIA primarily contains schedules, unclassified briefing memoranda, a speech draft, the Presidential Daily Diary for January 18, 2002, call logs, meeting participant lists, seating charts, White House press releases, lists of White House visitors, and a press briefing by White House Press Secretary Ari Fleischer. Electronic records include press clippings from news articles mentioning the phone call, White House press releases, and White House Press Secretary Ari Fleischer's talking points for a press gaggle.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

# **System of Arrangement**

The materials in FOIA 2019-0033-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files and George W. Bush Presidential Electronic Records.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) and folders processed in response to FOIA 2019-0033-F:

### George W. Bush Electronic Records

ARMS contains 86 assets, of which 82 are released in full, 2 are withheld in part, and 2 are withheld in full.

OA contains 27 assets, all of which are released in full.

WHO contains 3 assets, all of which are released in full.
