Scope and Content

The materials in FOIA 2021-0077-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2021-0077-F requested materials related to letters from Roberto Gonzalez Nieves to President George W. Bush.

This FOIA primarily contains letters to President George W. Bush from Roberto Gonzalez Nieves, Archbishop of San Juan de Puerto Rico, responses to those letters, correspondence tracking sheets, fax cover sheets, printed emails, articles, speeches, fact sheets, gift registers, legislative reports, tour requests, and public correspondence. Public correspondence includes condolences after 9/11, correspondence to Karl Rove, correspondence to President George W. Bush, resolutions transmitted to the White House, requests for letters, and invitations. Correspondence from Roberto Gonzalez Nieves mainly date between 2001 and 2003 regarding

the withdrawal of the military from Vieques as well as a pardon request, a letter regarding a prisoner, and condolence letters after 9/11 and the passing of Ronald Reagan. Responses to Roberto Gonzalez Nieves are from President George W. Bush, Karl Rove, Ruben Barrales, and the Department of the Navy.

System of Arrangement

The materials in FOIA 2021-0077-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Staff Member Office Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
