Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2021-0137-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2021-0137-F requested materials related to personal correspondence between President George W. Bush and Queen Elizabeth II of England.

This FOIA primarily contains correspondence between President George W. Bush and Queen Elizabeth II of a ceremonial nature, including letters of condolence and celebration, photographs of the 2008 State visit of Queen Elizabeth II and Prince Phillip to the United States, condolence letters on the passing of President Ronald Reagan, an advertisement book for the Boston Police Relief Association, event permit applications, caterer menus and invoices, holiday schedules, and invitation lists.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2021-0137-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.
