Scope and Content

The materials in FOIA 2018-0263-F[30] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[30] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing Casey between July 2003 and May 2006.

This FOIA primarily contains memorandum on National Energy Policy, cabinet reports, administrative alerts, press release for nominations delivered to the Senate, final copies of speeches, draft remarks, fact sheets, historical social security analysis, administrative emails scheduling social security meetings, event briefing papers, schedules, and articles. Records from

this segment date from July 14, 2003 to June 9, 2004 and February 14, 2005 to February 18, 2005.

System of Arrangement

The materials in FOIA 2018-0263-F[30] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Casey ARMS contains 52 assets, of which 45 are released in full, 0 are withheld in part, and 7 are withheld in full.

Casey Exchange_1a contains 173 assets, of which 88 are released in full, 11 are withheld in part, and 74 are withheld in full.

Casey 33Days_1 contains 5 assets, of which 3 are released in full, 0 are withheld in part, and 2 are withheld in full.

Casey 33Days_2 contains 28 assets, of which 13 are released in full, 15 are withheld in part, and 0 are withheld in full.
