Scope and Content

The materials in FOIA 2018-0263-F[33] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[33] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing Casey between July 2003 and May 2006.

This FOIA primarily contains speech drafts and transcripts, press pool reports, agendas, administrative emails, news articles, a legal opinion, and lists of Honorary Chairs, Awards and Memberships. Many of the news articles and emails discuss Cindy Sheehan and her antiwar protests after the death of her son Casey in Iraq. There are also several draft copies of the speech

President George W. Bush gave at the Pentagon on the War on Terror on September 22, 2005. Additionally, there are letters from Gold Star families to President George W. Bush. Records from this segment date from June 1, 2005, to September 22, 2005.

System of Arrangement

The materials in FOIA 2018-0263-F[33] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
