This FOIA primarily contains photographs of Vice President Dick Cheney and President George W. Bush alone at various events, meetings and briefings, as well as lunches in the Oval Office Dining Room from 2001 to 2009.

System of Arrangement

The materials in FOIA 2014-0116-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program.

2014-0116-F photos 2002 contains 462 photographs, all of which are released in full.

2014-0116-F_photos_2003 contains 621 photographs, of which 382 are released in full, and 239 are withheld in full.

2014-0116-F_photos_2004 contains 361 photographs, of which 166 are released in full, 187 are withheld in full, and 8 are withheld in part.

2014-0116-F_photos_2005 contains 301 photographs, of which 288 are released in full, 12 are withheld in full, and 1 is withheld in part.

2014-0116-F_photos_2006 contains 343 photographs, of which 285 are released in full, 53 are withheld in full, and 5 are withheld in part.

2014-0116-F_photos_2007 contains 429 photographs, of which 398 are released in full, and 31 are withheld in full.

2014-0116-F_photos_2008 contains 361 photographs, of which 311 are released in full, and 50 are withheld in full.
