Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Scope and Content**

The materials in FOIA 2014-0529-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2014-0529-F requested materials related to First Lady Laura Bush's trip to the United Arab Emirates, Saudi Arabia, Kuwait, and Jordan from October 20-26, 2007 to promote the U.S.–Middle East Partnership on Breast Cancer Awareness and Research.

This FOIA primarily contains briefings, trip books, schedules, correspondence, memoranda, brochures, photos, printed email, press releases, and drafts thereof. The bulk of these materials are related to and consist of planning and briefing materials such as event proposals, schedules and trip books. These records also consist of event photos and thank you notes. Electronic records consist of remarks, press releases, fact sheets, vetting lists, trip summaries, background

information, trip planning correspondence, correspondence between staff and press, interview requests, and staff discussions of press coverage.

## **System of Arrangement**

The materials in FOIA 2014-0529-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files and George W. Bush Presidential Electronic Records.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) and folders processed in response to FOIA 2014-0529-F:

## George W. Bush Electronic Records

Exchange contains 228 assets, of which 173 are released in full and 55 are withheld in part. RNC PST contains 1 asset, which is withheld in full.

OA contains 1 asset, which is released in full.

WHO contains 39 assets, of which 37 are released in full and 2 are withheld in part.
