FOIA 2021-0034-F requested videotapes WHTV 604 09/13/2001 Photo Op Tape #2 for 09/13/2001 - 09/16/2001 and WHTV 607 09/14/2001 Arrivals, Departures and OTRs - Trip to Camp David.

This FOIA primarily contains video footage of President George W. Bush and Mrs. Laura Bush arriving and giving a statement to the press at the Washington Hospital Center on 9/13/2001, a departure from the South Lawn via Marine One on 9/14/2001, a presidential statement from

Camp David on 9/15/2001 and an arrival via Marine One and statement to the press on the South Lawn on 9/16/2001.

System of Arrangement

The materials in FOIA 2021-0034-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
