FOIA 2021-0038-F requested White House Television (WHTV) video footage of a leadership forum at Justina Road Elementary School on September 10, 2001.

This FOIA primarily contains video footage of President George W. Bush visiting Justina Road Elementary School in Jacksonville, FL on September 10, 2001, and participating in a leadership forum. Footage includes remarks by Florida Governor Jeb Bush and Secretary of Education Rod Paige.

#### System of Arrangement

The materials in FOIA 2021-0038-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
