## Access

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

## Copyright

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

## Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

## **Scope and Content**

The materials in FOIA 2022-0130-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2022-0130-F requested textual materials related to the "Strategery Group" from January 2001 – March 2001.

This FOIA primarily contains memoranda, reports, correspondence, agendas, briefings, lists, fact sheets, handwritten notes, printed emails, invitations, newspaper and magazine clippings, schedules, and calendars. The materials are concerned with President George W. Bush's long-range policy initiatives, and the public's level of support for his administration's decisions. These include reports and briefings analyzing the results of polling and focus groups, presidential and legislative schedules for March 2001 – December 2001, scheduling proposals and their

impact on public support, Strategery Group meeting summaries, voting analyses of the 2000 election, discussion of President George W. Bush's travel during his first 100 days in office, discussion of media coverage of the first 100 days, comparisons to the first 100 days of previous presidents, and highlights and accomplishments of the first 100 days. Policy areas of emphasis are energy, education, taxes, and the environment.

#### System of Arrangement

The materials in FOIA 2022-0130-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
