FOIA 2023-0004-F requested materials related to National Security Council (NSC) records about Operation Phantom Fury.

This FOIA primarily contains electronic materials from the National Security Council (NSC) about Operation Phantom Fury, including press pool reports, press releases, and news articles and event timelines; speech drafts for an upcoming presidential event at Camp Pendleton in 2004; copies of the newsletter Insurgency Literature Review; and emails related to administrative or routine office functions. The NSC shared drive records include CRS Reports for Congress and copies of the booklet On Point.

System of Arrangement

The materials in FOIA 2023-0004-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
