ALLCON--

as you probably know, the President is hosting a meeting tomorrow (March 28, 1100-1145) for three CODELs recently returned from Baghdad: Warner, McCain, and Hoekstra. We had originally planned not to ask for participation from Baghdad, but given feedback we have received on the delegation's views, concerns and ideas, a high-level decision was made here to request that the Ambassador and General Casey participate by SVTS. They will not be expected to brief, but should be ready to participate in Qs and As; specifically, we would ask that they be prepared to respond to the following questions and concerns that may arise:

- * If we do not have progress on unity government soon, we should convene Dayton-style summit
- * Levin: we must move quickly with conditions on our forces to leverage the Iraqis to form a government - "Baghdad is burning and the Iraqis are talking."
- * Feingold: Briefings he received in Baghdad did not mention Al Qaeda, but were all about sectarian violence; thus President's rhetoric is not accurate.
- * Depts other than DoD are not contributing their share to the effort. Need more from DoJ and USDA.
- * Infrastructure continues to be poor: electricity, water, also - need more jails, detainees are being released because no criminal justice system to process them.

In addition, you should be aware of the statement issued by Sen.. McCain et al (attached at end of email).

I apologize profusely for the late notice, but the decision to request Baghdad participation was just made. Thank you very much in advance

Statement on National Unity Summit

Washington D.C. -- Today, U.S. Senators John McCain, Russell Feingold, and John Thune, with Governors Bob Riley (AL), Jon Huntsman (UT), Tim Pawlenty (MN), and Representatives Tom Udall (NM), Mark Kirk (IL), and Joe Schwarz

(MI) issued the following joint statement on the need for National Unity Summit in Iraq.

"We, a bipartisan group of senators, governors and congressmen, just returned from a visit to Iraq. We continue to be extremely proud of the service and sacrifice of the brave Americans and their allies serving in the cause of Iraqi freedom.

"Our delegation met with Iraqi government and party leaders from secular, Shia, Sunni and Kurdish parties. We stressed at every opportunity the

critical need for the rapid formation of a national unity government. With three months having passed since over 11 million Iraqis voted for a government, the time for action is now. We repeatedly urged Iraqi leaders at all levels to join in a unity government as a vital element in the struggle for success in Iraq.

"Iraqi leaders indicated that they would form a unity government within weeks. If it is not accomplished within that time, we encourage President Bush to continue to pursue any and all additional measures necessary to accomplish this critical goal. If the timeline given is not met, one option the President should consider is to urge all parties to convene a Dayton-style summit of political leaders to finish the creation of a

national unity government.

"Formation of a unity government will be a decisive factor in achieving success in this conflict. It will also accelerate the delivery of billions in aid promised by friendly western and Arab nations waiting for the formation of the new unity government."
