Scope and Content

The materials in FOIA 2014-0201-F[1] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2014-0201-F[1] requested emails sent to and from members of the George W. Bush Administration that contain any mention of former Vice President Albert Gore, Jr.

The first segment of this FOIA primarily contains correspondence regarding vandalism by the previous administration, failed email deliveries from outgoing staff, emails from the public, articles and newsletters concerning the Florida recount, and articles discussing the handling of 9/11 by a hypothetical Gore Administration. Emails that mention Al Gore but that are not specifically about him include policy papers, speech drafts, polls, legislative hearing transcripts, press briefing transcripts, political reports, RNC newsletters, miscellaneous articles and

unsolicited resumes. This segment contains emails sent between January 20, 2001 and September 30, 2001.

System of Arrangement

The materials in FOIA 2014-0201-F[1] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.
