Scope and Content

The materials in FOIA 2018-0060-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0060-F requested materials related to TSA spokeswoman/USDA speechwriter Jessie Nicholson or her husband Kevin Nicholson from 2005.

This FOIA primarily contains correspondence with Bush Administration officials about speechwriting positions, TSA newsletters, press releases from the USDA announcing her appointment, various farming and agricultural newsletters, emails sent by Jessie Nicholson to USDA co-workers, emails announcing her departure from the USDA, and a list of Schedule C employees.

System of Arrangement

The materials in FOIA 2018-0060-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Exchange contains 377 assets, of which 64 are released in full, 32 are withheld in part, and 281 are withheld in full.

40 Days contains 10 assets, all of which are withheld in full.

RNC PST contains 74 assets, of which 2 are released in full, and 72 are withheld in full.

OA contains 4 assets, all of which are withheld in full.

WHO contains 4 assets, of which 1 is released in full, and 3 are withheld in full.
