This FOIA contains photographs of meetings and events on June 4, 2002. Events pictured include an official portrait session with President George W. Bush and Mrs. Laura Bush, the White House Conference on School Libraries in the East Room, a visit and remarks by President Bush at the National Security Agency, a South Lawn arrival by the President, a Welfare-to-Work graduate event, a phone call with FBI Director Robert Mueller and an Oval Office photo opportunity with departing White House staff. Also included are meetings between President Bush and senior staff regarding federal immigration law and special education, a speech writing session with Karen Hughes and Mike Gerson, a meeting with bipartisan senators on welfare

reauthorization, a greeting with actor Nicolas Cage, and Mrs. Laura Bush discussing West Wing decorations with staff and decorators.

System of Arrangement
