Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2022-0133-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2022-0133-F requested textual records associated with the "Strategery Group" from October 2001 – December 2001.

This FOIA primarily contains agendas, briefings, meeting notes, surveys, polls, calendars, and schedules regarding the administration's policy priorities and timelines. Included are long-range calendars marked with tentative meetings, trips, events, and legislative dates; long-range scheduling requests and invitations; briefings analyzing public opinion polls showing the level of public support for President George W. Bush and his administration's various initiatives; and lists of staff names associated with the Long-Range Strategy / Strategery Group. There are also

two folders of daily schedules from the Chief of Staff office files, some of which list the dates and times of Strategery meetings.

System of Arrangement

The materials in FOIA 2022-0133-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Staff Member Office Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
