Scope and Content

The materials in FOIA 2016-0181-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2016-0181-F requested textual materials related to President George W. Bush's speech in Tbilisi, Georgia on May 10, 2005.

This FOIA primarily contains memoranda, printed emails, articles, lists, information sheets, schedules, reports, charts, maps, and speech drafts. The bulk of the items are background materials and schedules for President George W. Bush's May 2005 visit to Tbilisi, Georgia. Included are maps and information sheets regarding each stop in Georgia and daily schedules of events. There are also speech drafts for President George W. Bush's speech in Tbilisi's Freedom Square, as well as his joint press availability with Georgian President Mikheil Saakashvili. These

drafts are accompanied by information sheets, printed emails, articles, and memoranda that provide additional input and edits for the speeches.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2016-0181-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
