FOIA 2016-0277-F requested photographs of President George W. Bush and cake.

This FOIA primarily contains photographs of President George W. Bush and cake at various events including birthday celebrations for the President and Mrs. Laura Bush, celebrations for staff at the White House and aboard Air Force One, an Evergreen Chapel Rededication at Camp David, Fourth of July celebrations, Barny's first birthday party, and a dinner in honor of President Gerald Ford's 90th birthday. Photographs also include birthday cake presentations for Lance Armstrong, Representative Richard Gephardt, Senator John McCain, Senator Tom Carper, and Pope Benedict XVI.
