Scope and Content

The materials in FOIA 2021-0031-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2021-0031-F requested video footage from September 11, 2001, on Tapes WHTV 606 and WHTV 1501.

This FOIA primarily contains video footage depicting the arrival, departure, and remarks of President George W. Bush, as well as a press statement by Ari Fleischer at Barksdale Air Force Base in Shreveport, Louisiana on September 11, 2001. Footage also includes a reading demonstration at Booker Elementary school in Sarasota, Florida and a rehearsal and address to the nation from the Oval Office by the President on September 11, 2001.

System of Arrangement

The materials in FOIA 2021-0031-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
